SUMMARY

Cpl. McNally reports... On 12-07-12 at 0153 hrs, officers responded to the HD Hideout, 6201 W. Mitchell St. regarding a trouble call. Investigation revealed Nicole L. Cameron (f/w, 05-19-78) and Laura A. Rivera (f/w, 05-23-77) got into an argument inside the tavern. During the argument, Scott R. Baumann (m/w, 06-14-78) punched Cameron in the head. Baumann also punched Mark R. Van Beek (m/w, 02-20-63) in the head several times. Baumann was not arrested. He was ordered in for the booking process on 12-07-12 at 2300 hrs. Baumann was later mugged/printed and issued two municipal citations for battery.

On 12-07-12 at 0153 hrs, I responded to 6017 W. Mitchell St. to speak with Mark R. Van Beek about an incident that occurred at the HD Hideout, 6201 W. Mitchell St.

STATEMENT - MARK R. VAN BEEK (victim)

Van Beek stated he observed Nicole L. Cameron and Laura A. Rivera physically fighting inside the tavern. Van Beek admitted that both women were wrestling one another, but would not provide specific details as to how the argument started. While both females were wrestling, Van Beek witnessed Scott R. Baumann punch Cameron in the left side of head. Van Beek described the punch as a "sucker punch." He stated Cameron fell to the floor and appeared to be "knocked out."

Van Beek stated he tried to separate all the subjects and stop the fight. While doing so and still inside the tavern, Van Beek stated Baumann punched him three times in the head. Van Beek suffered a laceration to the inside of his upper lip, a laceration to the left side of his face and an abrasion/swelling to the left side of his head. Van Beek thought Baumann may have been wearing brass knuckles but never observed any weapons. Van Beek refused medical attention several times, stating "it will heal."

While speaking with Van Beek, I detected a strong odor of ingested intoxicants emitting from his breath. His eyes were glassy and bloodshot and his speech was slurred. Van Beek admitted he had consumed two pitchers of beer. I asked him if he was intoxicated and he stated, "no, it's only beer."

Lack of Consent: Van Beek did not give Baumann permission to punch him several times in the head.

Van Beek wanted Baumann arrested for his actions.

The digital media card was sealed in an envelope and secured in the WAPD property room.

STATEMENT - NEIL A. PANOSIAN (bartender)

I responded to the HD Hideout, 6201 W. Mitchell St, and made contact with the bartender, Neil A. Panosian. He stated Cameron and Rivera were wrestling inside the tavern and causing a disturbance inside the tavern, however, he did not see how the physical altercation started between the two. Panosian did observe Baumann punch Cameron in the head. Panosian advised me that he told Baumann and Rivera to leave the tavern. After Rivera and Baumann left the tavern, Van Beek followed the two outside. Panosian does not know what occurred outside the tavern, but stated Van Beek left, "looking for a fight."

I asked Panosian why he did not call the Police immediately after the altercation. He stated it did not cross his mind to do so and that he didn't know that was the proper procedure. Panosian admitted that he discussed this altercation with Daniel Seiy and together they decided that they would contact the West Allis Police Department in the morning to report this incident.

PHONE STATEMENT - LAURA A. RIVERA

On 12-07-12 at approximately 0300 hrs, I made phone contact with Rivera. She stated she did nothing wrong. She admitted that she approached Cameron to say hi and introduce herself as Baumann's girlfriend. Rivera said that for no apparent reason, Cameron grabbed her by the hair and tried to throw her to the floor. Rivera admitted to being at the tavern and admitted she was in a physical altercation with Cameron.

Rivera denied the allegation that Baumann punched Cameron in the head. Rivera stated she had a scratch on her face, but that she did not need medical treatment. I asked her to meet with me so I could photograph her injuries. She would not meet with me stating she was in bed and not at home. She would not provide an address for me to come meet her.

PHONE STATEMENT - SCOTT R. BAUMANN (offender)

After speaking with Rivera, she handed the phone to Baumann. Baumann denied the allegations that he punched anyone. Baumann stated Rivera was attacked by his ex-girlfriend, Cameron, for no reason. Baumann was agitated and upset on the phone. I asked him to provide details of how the argument between Rivera and Cameron started and he was unable to do so. Baumann admitted that he shoved Cameron to get her away from Rivera. Baumann was not sure, but thought he may

have shoved her in the face.

Baumann and Rivera then left the tavern on their own accord. Baumann stated Van Beek followed them outside and continued arguing with them. Baumann stated Van Beek was upset and shoved him in the chest. Baumann denies punching Van Beek but admitted that he shoved him. Baumann would not say where he shoved Van Beek or explain how Van Beek obtained his injuries.

I ordered Baumann into the WAPD for the booking process at 2300 hrs. on 12-07-12.

BOOKING

On 12-12-12 at 0115 hrs, Baumann came into the station on his own. He was mugged/printed and booked under WAPD booking #2012006300, WAPD #A-27632. I completed and issued municipal citation #M-98979 and #M-98978.

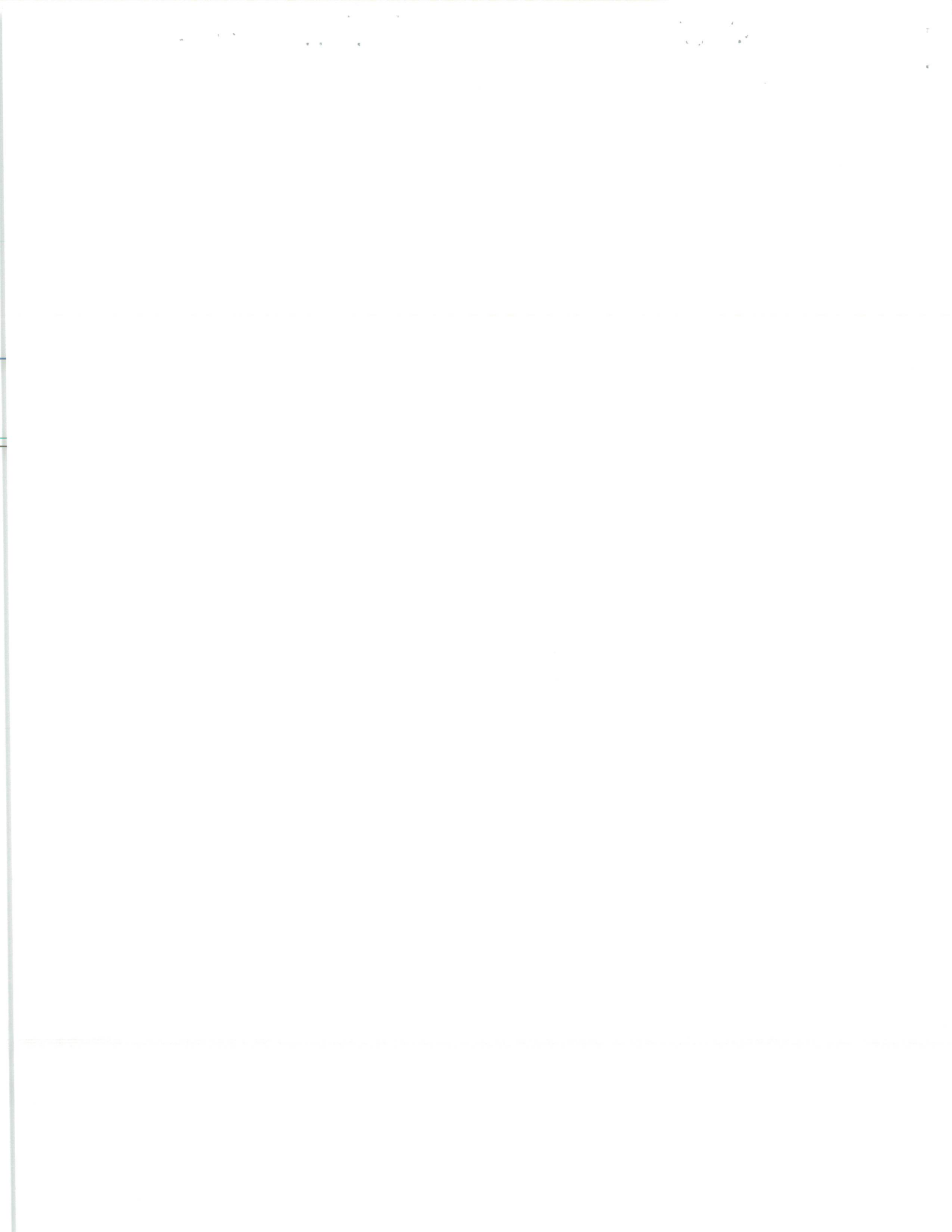
Baumann asked me if he could say one thing prior to leaving. I advised him that I could not speak with him regarding this incident without reading him his Miranda rights and recording the interview. Baumann then blurted out, "I was protecting my girlfriend."

Again I told Baumann that I would conduct a Mirandized and recorded interview with him about the incident. Baumann advised me that he did not want to provide a statement regarding this incident. Baumann was upset that Cameron was not being issued any citations.

CASE DISPOSITION

Baumann was issued two municipal citations for battery.

have 'blacked out' for a few moments as a result of Baumann hitting her. The next thing she remembers is walking out of the bar with Van Beek back to the 6100 block of W. Mitchell St. Van Beek called for the police to respond based on Cameron's injuries.

A medical unit was called and responded on scene, based on the fact Cameron was bleeding out of her left ear and complained of a deep headache. Cameron refused to go to the hospital and signed the release form. She was given a business card with the case number on it.

LACK OF CONSENT

Cameron did not give Baumann consent to punch her in the head.
