NARRATIVE**INITIAL INVESTIGATION**

Officers responded to a report of a fight at Doppelgangers, 1022 S. 60 St. Dispatched advised that the offender left the bar in a GRN Jeep. Officer Blunt the first Officer on scene initiated a traffic stop with this vehicle (See Officer Blunt's Supplement Report). Officer McNally assisted Officer Blunt with the traffic stop.

Officer Sterling and I responded to the bar and there were minor injuries to three victims. The victims were identified by a Wisconsin Photo Drivers License as, Anthony J. Bellanti Jr M/W 03/03/80, Jay M. Missiaen M/W 12/29/59 and Paul S. Sobczak M/W 04/14/60. The victims declined medical treatment

Inside the bar, Officer Sterling spoke to the bar owner, Tammy L. Dopp F/W 01/23/64 (See Officer Sterling's Supplement Report) while I spoke to the victims.

Officer Treep also responded to the bar and spoke with the girlfriend of Missiaen, Katherina L. Holter F/W 06/26/64. Officer Treep also assisted with the showup (See Officer Treep's Supplement).

Investigation eventually led to the arrest of Peter D. Alberti M/W 07/16/75 for Battery. Alberti was issued Municipal Citation M-202990 and released.

STATEMENT OF ANTHONY J. BELLANTI

Bellanti stated a female party, later identified as Katherina L. Holter F/W 06/26/64, asked a M/W, Dark Hair, Pony Tail a question. The M/W later identified as Peter D. Alberti M/W 07/16/75 became defensive and began swearing at Holter. Bellanti stated that since Holter is, Jay M. Missiaen's girlfriend, Missiaen stepped in between Holter and Alberti to calm things down. Bellanti stated that Alberti slapped Missiaen in the face then punched him in the face. Bellanti tried to grab and control Alberti's arms, but Alberti got away and punched him in the face with a closed face causing him pain.

Alberti was described as having Dk Hair, Pony Tail, Dk Beard.

I observed the left side of Bellanti's chin to be swollen. Bellanti declined medical treatment.

Bellanti did not give Alberti permission to punch him in the face causing him pain.

STATEMENT OF JAY M. MISSIAEN

Missiaen stated that his girlfriend, Holter, asked Alberti a question. She asked him a question because she thought she knew him. Alberti became very defensive and started swearing at Holter. Alberti was in Holter's face swearing and Holter tried to apologize. Missiaen stated that he wanted Alberti to stop so he got in between the two to separate them and was slapped in the face by Alberti. Alberti then punched him in the face. Alberti then punched Bellanti in the face.

Alberti was described as having Dk Hair, Pony Tail, Dk Beard.

I observed the left eye of Missiaen to be red and swollen shut. Missiaen was given a bag of ice by the bar and declined medical treatment.

LACK OF CONSENT

Missiaen did not give Alberti permission to slap and punch him in the face causing him pain.

STATEMENT OF PAUL S. SOBSCZAK

Sobsczak stated that Alberti was talking to Holter at the bar. When Missiaen stepped in between Alberti and Holter, Alberti swung at Missiaen. Sobsczak stated he then tried to grab Alberti's head but was hit by another M/W with BLD hair.

Alberti was described as having Dk Hair, Pony Tail, Dk Beard.

I observed the bottom lip of Sobsczak to be bleeding. Sobsczak declined medical treatment.

LACK OF CONSENT

Sobsczak did not give the unknown M/W permission to punch him in the face causing him pain.

SHOWUP

Based on the descriptions Bellanti, Missiaen, Sobsczak gave of the offender, Dk Hair, Pony Tail, Dk Beard, the description of and possible license plate number of the vehicle, the close proximity of the traffic stop and distance to the bar, the defendant's denial of being at the bar, a show up was conducted.

I reviewed this with Sgt. Corwin and Officer Sterling prior to conducting the showup.

The showup was conducted at W. Greenfield Ave. and S. 64 St. This location is approx. a half a mile from 1022 S. 60 St. The show up occurred approx. 10 minutes after Officer Sterling and I arrived at 1022 S. 60 St.

Officer Sterling and I transported Missiaen to W. Greenfield Ave. and S. 64 St. Missiaen was seated in the rear of the squad. On the way to the location I explained to Missiaen that there are several occupants in the vehicle and that he needs to be 100% sure that the person he observes is the one that slapped and punched him or was involved in the disturbance.

When we arrived to the location, I rolled down the back window so that Missiaen had a clear view of the defendant. My squad was facing N/B on S. 64 St. The defendant was positioned on the N/W corner approx. 20 feet from my squad car.

Missiaen was 100% sure that Alberti was the individual that slapped and punched him.

Missiaen was unable to identify the 4 other occupants in the vehicle.

Officer Treep transported Bellanti and Sobsczak separately (See Officer Treep's Supplement Report).

ARREST DECISION

Based on the victims visible injuries, statements and the positive identification during the showup, Alberti was placed under arrest for Battery. Alberti was transported to WAPD for booking.

STATEMENT OF PETER D. ALBERTI

On 02/18/07 at approx. 0300hrs in WAPD Booking Interview Room B, using WAPD Olympus Digital Voice Recorder P18 and memory card P18-3, I read Alberti his Miranda Warnings in accordance with WAPD Standard 44.2.3 and WAPD Directive 42.016 and he refused to answer questions.

The interview was ended on 02/18/07 at approx. 0301hrs.

I placed the memory card P18-3 in a media envelope and placed it in the media drawer in the ID Bureau.

Officer Treep reports...

INITIAL CALL

I was dispatched to 1022 S. 60th St. to assist officers with an investigation. Upon arrival I spoke to a witness to this incident identified by WI DL as Katherina L. Holter.

STATEMENT FROM KATHERINA L. HOLTER

Holter stated a group of males came into Dopplegangers. Holter said she thought she recognized one of the males from a previous contact while inside Dopplegangers. Holter asked the male, described as a w/m, approx 30 yoa, long ponytail, and a beard, where her money was. The male stated, "I don't owe you shit!" The male began swearing and cursing demanding a free beer. Holter apologized and said she thought she recognized him as owing her money. Holter's boyfriend, Jay M. Missiaen, stepped in front of Holter because the male was coming towards her. The male then slapped Missiaen across his face with a open right hand. Holter said all she can remember next is a fight broke.

FURTHER INVESTIGATION

I was assigned to bring two of the victim's, Paul S. Sobczak and Anthony J. Bellanti, to do a showup at 64/Greenfield. Officers had a vehicle stopped that matched the description as the vehicle leaving Dopplegangers that were involved in the fight. I first brought Paul S. Sobczak to the area. Sobczak identified Peter P. Alberti as the male party who started the fight and the one who punched Missiaen in the face. Sobczak stated he was 100% sure that was the man. I dropped Sobczak off and picked up Bellanti to conduct the showup.

Bellanti was shown each individual from the traffic stop. Bellanti identified Peter P. Alberti as the male party who started the fight and the one who punched Missiaen in the face. Bellanti stated he was 100% sure that was the man.

STATEMENT-TAMMY L. DOPP (WITNESS)

Officer B. Sterling reports...

I assisted on this call and spoke to the owner of Dopp's Tavern, Tammy L. Dopp.

Dopp stated everything was going fine in the bar and there were no problems. At approx. 0100 Hrs., a group of approx. 10 parties came inside the bar. Dopp stated there were 5 males and 5 females.

Dopp stated one male party she described as approx. 32 yrs old, beard, pony tail, and alot of tattoos. This party was later identified as Peter Alberti. Dopp stated a female, Katherina L. Holter, confronted Alberti and asked him if he was involved in another incident. Alberti became upset and started swearing at Holter. Holter asked Dopp if Alberti was the guy and she told Holter that he was not. Holter then apologized several times to Alberti.

Alberti refused to accept Holter's apology. Alberti was yelling, swearing, and eventually called Holter a "cunt".

Dopp stated that Holter's boyfriend, Jay Missiaen, confronted Alberti and told him to "knock it off". Dopp stated Alberti then slapped and punched Missiaen in the face.

Dopp stated several other parties from the bar and Alberti's party ran towards the altercation. Several punches were thrown by member's of Alberti's party, but she could not describe them.

Dopp stated she has never seen Alberti or any of the other parties that came with him. The fight eventually broke up, the police were called and the suspects left in two different vehicles, one was a green SUV.

NARRATIVE

CALL FOR POLICE

On 02/18/07 at 0115 hours, I responded to Doppelgangers, 1022 S 60 St, for a report of a fight inside the bar. I arrived outside the bar and was flagged down by a male who was holding his nose with a white cloth or t shirt. The male pointed to a green Jeep SUV and stated the occupants in the vehicle were the ones who had assaulted him. The man gave a partial plate of 226.

I then observed a green Jeep SUV, which was parked on the east side of the street north of Doppelgangers, leave the area heading north on S 60 St and then west on W Mineral St.

TRAFFIC STOP

I was able to locate and stop this vehicle vehicle at S 64 St and W Greenfield Av, for possible involvement in the fight at Doppelgangers. The vehicle I stopped was a green Jeep Cherokee, bearing WI plate 226CJM. Officer McNally arrived and assisted me. There were 5 occupants in the vehicle.

I spoke to the driver, identified by her Wisconsin driver's license as Jennifer L Alberti, f/w 12/10/75. I asked Alberti where she was coming from and Alberti stated they had left Kokopellis, a bar/restaurant located at 6001 W Madison St. Alberti stated she has been the designated driver for her brother's birthday.

I asked Alberti if her group had been at Doppelgangers, 1022 S 60 St. Alberti stated her group was at a alot of bars tonight but that was not one of them. I asked if anyone in her group engaged in a altercation with anyone. Alberti denied that anyone in her car engaged in a altercation at any of the bars they visited.

The other occupants in the vehicle were identified as Daniel J Polewczynski, m/w 02/17/81, Amanda R Anderson, m/w 08/07/82, Brian P Mandelin, m/w 01/06/75 and Peter D Alberti, m/w 07/16/75.

All of the occupants denied being in a altercation with anyone and stated they were just out celebrating Polewcznski's birthday. The only occupant in the car who was uncooperative was the front passenger, Peter Alberti, who was very intoxicated. At first, Peter refused to give his identification to Officer McNally and began yelling that he knew his rights and didn't have to give officers his name.

Officer McNally was eventually able to get Peter's identification.

Officer Sterling and Officer Gold arrived to my location with the victims of the alleged assault at Doppelgangers. All occupants of the vehicle I had stopped were
