You are hereby notified that a sworn complaint, a copy of which is attached, has been duly made and filed, requesting a hearing on the non-renewal of the 2020-2022 Operator’s License, license number 8852, Wis. Stat. §§ 125.04(5)(a)1, 125.12(3), 125.12(2)(ag)1, and 125.12(2)(ag)4.


NOW THEREFORE, you, Leonard Perrin, are hereby summoned to appear before the License and Health Committee of the West Allis Common Council in the Common Council Chambers of the West Allis City Hall, 7525 West Greenfield Avenue, West Allis, Wisconsin, on August 4, 2020, at 5:30 p.m., or as soon thereafter as this matter can be heard for the special meeting, to admit or deny the allegations in the complaint. You may be represented by counsel on this date.

In the case of your failure to appear as required by this summons, the allegations in the complaint against you shall be taken as true and, if the License and Health Committee of the West Allis Common Council finds the allegations sufficient, a recommendation that your license(s) be suspended or revoked will be made to the full Common Council. The Common Council may then vote to suspend, revoke, or not renew your license(s).

You are further notified that if you appear as required by this summons and contest the allegations in the complaint, a hearing will be scheduled at a later date before the License and Health Committee, at which time you may be represented by counsel, cross examine the witnesses who testify adversely against you, and present witnesses in your own behalf. A written transcript of said hearing shall be made and you may obtain a copy of the transcript of this proceeding at your expense.

COMPLAINT

Leonard Perrin

Vince Vitale, Alderperson for the First District of West Allis and Chair of the West Allis License and Health Committee, being duly sworn, on oath deposes and states as a complaint against Steffek LLC, as follows:


1. That the complainant is a resident of the City of West Allis.
2. That this complaint is based upon information and belief established by the complainant's review of official records maintained by the State of Wisconsin and City of West Allis.
3. That Leonard Perrin has applied for the renewal of a 2020-2022 Operator's License.
4. That Leonard Perrin had previously held a 2018-2020 Operator's License under license number 20-355, which expired on June 30, 2020.
5. That Leonard Perrin is the current holder of a Provisional Operator's License which is valid from July 1, 2020, until September 1, 2020, or until the regular renewal license is granted to the applicant.
6. That on January 1, 2020, Leonard Perrin was convicted of Operating While Intoxicated in violation of Wis. Stat. § 346.63, from an offense that occurred on or about November 5, 2019, in the City of West Allis.

7. That pursuant to Wis. Stat. § 125.04(5)(a)1, licenses and permits related to alcohol beverages may only be issued to persons who do not have an arrest or conviction record that substantially relates to the licensed activity, unless they show competent evidence of rehabilitation. *See* Wis. Stat. §§ 125.04(5)(a)1 and 111.335(3) & (4).
8. That based on the conviction listed in this complaint, Leonard Perrin has not met the necessary qualifications to hold a license or permit related to alcohol beverages due to the conviction for the operating while intoxicated offense being substantially related to the activities regulated under the Operator's License in violation of Wis. Stat. §§ 125.04(5)(a)1, and therefore are grounds for suspension, revocation of the provisional license and/ or nonrenewal of the license pursuant to Wis. Stat. §§ 125.12(3), 125.12(2)(ag)1, and 125.12(2)(ag)4.

WHEREFORE, Alderperson Vince Vitale requests that Leonard Perrin be summoned to appear before the License and Health Committee of the West Allis Common Council to answer this complaint and, if the material allegations of the complaint are denied, that a hearing be held to determine whether the permits and licenses possessed and applied for by Leonard Perrin should not be renewed, suspended or revoked.


