The following is a synopsis of reported incidents involving licensed businesses, including reported tavern violations and calls for police service for the month of September 2010. This report also includes two reports from August.

Incident reports:

Case 10-007905, 08/20/10 at 0100hrs. Paulie's, 8031 W Greenfield Ave

On August 23rd, 2010 a male came into the station to report being assaulted at Paulie's on the above stated date and time. The male stated that he was talking to a male party he knew when the male slammed his face into the bar three times. Through interviews and retrieved video from the tavern the male's story was confirmed. The offender refused to come into the station and was mailed a citation for Battery.

Case 10-007850, 08/21/10 at 0220hrs. Smokin Joe's, 6139 W Beloit Rd

On the above date and time officers were sent to Smokin Joe's in regards to a patron stating that an employee of the tavern struck him. There were conflicting stories between the victim who called and the employee. The victim did have swelling to his left eye area, a bloody lip and redness to the left side of his face. No citations issued at this time.

Case 10-008304, 09/04/10 at 0130hrs. Smokin Joe's, 6139 W Beloit Rd

On the above date and time officers responded to Smokin Joes for a report about the same employee referenced above being struck in the head with a beer bottle. On 09/09/10 the offender was charged at the Milwaukee County District Attorneys Office with one count of misdemeanor battery while armed.

Call 10-042683, 09/10/10 at 0005hrs. Tap City 7207 W National Ave

On the above date and time officers responded to Tap City for loud music coming from the parking lot area. It was determined that the noise was actually music coming from the open back door of the tavern. The bartender was informed of the problem and closed the door.

Case 10-008518, 09/11/10 at 0256hrs. Havana Lounge, 9505 W Greenfield Ave

On the above date and time officers observed five parties in the above named establishment with drinks on the bar. The bartender in charge had an expired bartenders license. The bartender in charge was mailed citations for operating without a licensed party on the premises and for allowing patrons to remain on license premises after hours. The owner was also cited. It should be noted that the bartender appeared at the 09/28/10 meeting for renewal of her license and claimed that there was a licensed bartender on scene during bar hours. She then admitted that when officers arrived there was no licensed bartender on scene.

Call 10-043785, 09/16/10 at 2350hrs. Painted Parrot, 8028 W National Ave.

On the above date and time officers were called to a noise complaint at the above named establishment. The windows were open and a live band was playing inside. The owner was notified of the complaint and closed the windows.

Call 10-044690, 09/23/10 at 0027hrs. Network Tavern, 9541 W Cleveland Ave.

On the above date and time officers were called to a noise complaint at the above named establishment. The windows and doors were open and music could be heard outside. The bartender was notified of the complaint and closed the doors and windows.

Case 10-008882, 09/24/10 at 0025hrs. Mario's, 1900 S 60 St.

On the above date and time a West Allis Police Sergeant was parked in the 5900 block of W. Burnham Ave observing a crowd out in front of Mario's. Several of the parties appeared intoxicated and were yelling at passersby. One of the parties approached the Sgt and initiated a conversation. This party appeared intoxicated and the Sgt checked his ID to see if he was of age. The party came back with two warrants. While attempting to arrest the party several parties who were outside of the tavern began yelling and walking towards officers. One other party was arrested for Disorderly Conduct before order was restored.

Call 10-045195, 09/26/10 at 0217hrs. Magoo's, 8911 W National Ave.

On the above date and time officers responded to a complaint of a fight at the above name establishment. A male party who was bleeding reported being struck by an unknown male. The victim was attending a bachelor party. The party refused assistance from the police or rescue personnel who were called.
