RESOLUTION R-2026-0604**

**RESOLUTION APPROVING A NEIGHBORHOOD SMALL GRANT PROGRAM
COMMUNITY IMPACT GRANT TO THE LIBERTY HEIGHTS PARK
NEIGHBORHOOD ASSOCIATION OF UP TO \$1,000**

WHEREAS, the Mayor and Common Council of the City of West Allis, along with staff and citizens, recognize the importance of developing and maintaining healthy neighborhoods throughout the community; and,

WHEREAS, the Common Council created the City of West Allis Neighborhood Small Grant Program in 2014 (Resolution R-2014-0099) to offer support to established neighborhood associations to unite around common goals, foster community pride, and enhance public spaces; and,

WHEREAS, the grant application (Exhibit A) submitted by the Liberty Heights Park Neighborhood Association (LHPNA) has been reviewed by staff and recommended to the Mayor in accordance with program policies; and,

WHEREAS, the grant meets the criteria of the West Allis Neighborhood Small Grant Program to provide neighborhood associations assistance to support projects that will engage residents, build community, and enhance the neighborhood and quality of life in the area.

NOW THEREFORE, be it resolved by the Common Council of the City of West Allis that it approves a Community Impact grant request under the City of West Allis Neighborhood Small Grant Program for the LHPNA of up to \$1,000.

BE IT FURTHER RESOLVED that the Mayor or designee is authorized to enter into a grant agreement between the City of West Allis and the LHPNA for up to \$1,000, and the parties agree to the following:

1. Grant. The City of West Allis will provide a Community Impact Grant to the LHPNA in the amount of \$1,000.
2. Use. The LHPNA will use the funds in accordance with project details specified in Exhibit A.
3. Records. The LHPNA shall maintain records of expenditures for a period of seven years.

BE IT FURTHER RESOLVED that up to \$1,000 will be appropriated from the West Allis Neighborhood Small Grant Program Community Impact grant fund (Account # 100-8201-517.37-01) upon approval.


