An Ordinance to Establish Parking Restrictions on the East Side of the North 300 Feet of the 3000 Block of S. 92 St.

PART I. Pursuant to Section 10.10 of the Revised Municipal Code, the following parking restriction is established:

Street: S. 92 St.

Block: North 300 Ft. of the 3000 Block

Side: East

Restriction: 2 Hour Parking 8:00 AM to 5:00 PM, Monday - Friday

PART II. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

PART III. This ordinance shall take effect and be in force from and after its passage and publication.
