**RESOLUTION TO ENTER INTO A MAINTENANCE COVENANT WITH THE  
MILWAUKEE METROPOLITAN SEWERAGE DISTRICT (MMSD) FOR THE  
MAINTENANCE OF TREES PLANTED THROUGHOUT THE CITY FUNDED BY  
MMSD GREEN SOLUTIONS IN 2025.**

**WHEREAS**, the City of West Allis (the “City”) recognizes the importance of the proper maintenance of Green Infrastructure for it to continue managing storm water in a sustainable manner; and,

**WHEREAS**, in this action the City has declared its intent to properly maintain the trees planted in 2025 throughout the City; and,

**WHEREAS**, the Milwaukee Metropolitan Sewerage District will provide funding for the installation of the trees through their Green Solutions Program once this Maintenance Covenant is in place; and,

**NOW THEREFORE**, be it resolved by the Common Council of the City of West Allis that the City of West Allis grants Milwaukee Metropolitan Sewerage District a Maintenance Covenant for the installation of trees planted in 2025 throughout the City.

**BE IT FURTHER RESOLVED** that the City Engineer is directed and authorized to enter into a Maintenance Covenant with Milwaukee Metropolitan Sewerage District in compliance with the funding requirements.


