Rachel was released from custody.

**NARRATIVE**

**INITIAL CALL**

On 9-15-13 at 2146 hrs, I, Officer Manthe, was working as patrol squad 217 for the City of West Allis when I responded to 1100 S 60 St, Double Barrel Tavern with Officer A Cerqua and Officer Moews for two females yelling at children. Upon arrival, I observed a White in color Oldsmobile, WI reg 652UGW, stopped in traffic facing westbound on W Washington St at S 60 St without headlights illuminated during hours of darkness. Officer A Cerqua made contact with the person seated in the driver seat of the vehicle and I made contact with the passenger of the vehicle, identified by Valid WI DL as Rachel L Alvey, F/W DOB: 4-28-71.

**CONTACT WITH OFFENDER- RACHEL L ALVEY**

I told Rachel Alvey to step out of the vehicle and she stared at me. I again instructed Rachel to step out of the vehicle and she asked, "Why?" I told Rachel that I was investigating a disorderly conduct complaint and that she was to step out of the vehicle and speak with me on the sidewalk. Rachel stepped out of the vehicle and appeared very unsteady, almost falling down.

I spoke with Rachel on the Northeast corner of the intersection and advised her that the West Allis Police Department had received a complaint regarding two women yelling at children in the Double Barrel Tavern. Rachel told me to go and investigate some real crime.

I could smell a strong odor of ingested alcohol on the breath of Rachel Alvey while she was speaking and her eyes appeared watery, consistent with someone who is very impaired by alcohol.

I asked Rachel who the automobile she was in belonged to and she stated it was her car. Rachel advised the person driving the vehicle was her son, Joseph Alvey. I asked Rachel how old Joseph was and she said that he was sixteen. I again asked

her if he was sixteen years of age and she said he was and that he had a driver license.

I asked Rachel what happened in the tavern and she would only tell me that the people in the tavern were assholes and that they were affiliated with the mafia. I again asked Rachel to explain what happened in the tavern and she said I should be investigating the shootings on the North side and not wasting everyone's time.

During my contact with Rachel, Officer A Cerqua advised she had spoken with Joseph Alvey and that he stated he was fourteen years of age, did not have a driver license, and was trying to get his mother home.

I asked Rachel why she lied to me about her son's age and she told me she did not lie. I advised Rachel she had told me that her son was sixteen years of age and that he was valid to drive an automobile. Rachel again stared at me and asked me if I thought I was tough and again inquired why I wasn't on the North side investigating shootings.

Rachel began reaching into her purse and I told her to keep her hands out of her purse for officer safety reasons. She did not take her hands out of her purse. I grabbed her hand and her purse and told her to remove her hand from her purse. Rachel responded by telling me not to grab her purse and continued to try and reach inside her purse. Officer A Cerqua and I took the purse from Rachel. Rachel attempted to take a step to her right, tripped on a step, and fell to the ground. Rachel did not receive any injuries from the fall and was escorted to her feet by officers.

**ARREST DECISION**

Based on Rachel lying to police in an attempt to deceive police during this investigation and having her juvenile, unlicensed child drive her vehicle because of her impairment from alcohol, Rachel Alvey was arrested for obstructing an officer and contributing to the delinquency of a minor. She was transported to the West Allis Police Department in the back of squad 21. During transport, Rachel continued to yell profanities.

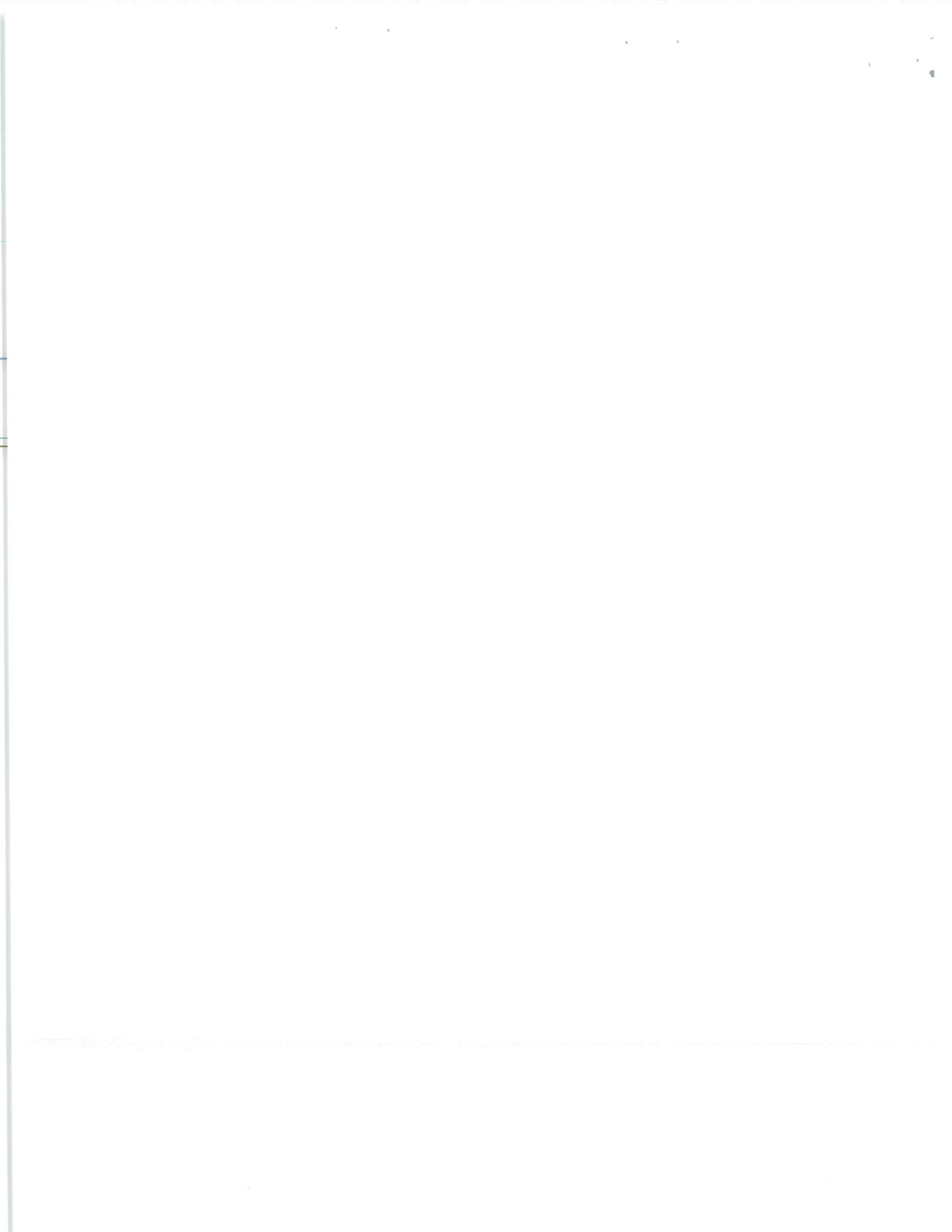
**VEHICLE DISPOSITION**

**NARRATIVE**

**INITIAL CALL**

On 09/15/13 at 2146hrs officers responded to Double Barrel, 1100 S. 60 St., for two intoxicated female parties who were swearing at their children. Upon arrival, I observed a white sedan in the middle of the street with a young male driver and an intoxicated female passenger. One of the patrons at the tavern advised the male driver, Joseph M. Alvey, M/W 12/18/98, was 14 years old, and his intoxicated mother, Rachel L. Alvey, F/W 04/28/71, was trying to make him drive her home.

I advised Joseph to exit the driver's seat of the vehicle and speak with me regarding the incident.

**STATEMENT OF JOSEPH**

Joseph explained Rachel drove over to Double Barrel a few hours earlier when she was sober. Joseph stated Rachel was having problems with his father so she went to the tavern to drink. Joseph was standing outside the tavern for an extended period of time trying to get his mother to leave, but she refused to do so.

Rachel started fighting with the bartender and lost her purse and was walking around with no shoes on. Rachel eventually left the bar, but she was too intoxicated to drive home. Joseph stated his father refused to pick him and

his mother up, and he just wanted to get home. Joseph said he eventually got in the driver's seat of the vehicle to drive his mother home.

TRANSPORT TO RESIDENCE

Rachel lied to Officer Manthe when he asked her about the age of her son. Rachel was arrested for obstructing, and her vehicle was towed to N&S Towing for safekeeping because there was no valid sober driver to take custody of the vehicle.

Once Joseph's mother was arrested, I provided Joseph with a courtesy ride to his residence in Milwaukee, and I turned him over to his father.

**CASE ASSIGNMENT**

Detective Christina Porter reports...

On 09/30/13 I was assigned by Lt. Johnson to follow up on this contributing to the delinquency of a minor/obstructing report.

The report states that on 09/15/13 Officers located Rachel L. Alvey in a vehicle with her fourteen year old son, Joseph Alvey, in the driver's seat. Rachel told officers Joseph was sixteen and had a valid driver's license. Joseph said he was trying to get his intoxicated mother to leave the bar, but she refused, and his father refused to come to the bar to assist him. Joseph said he decided he would have to drive his mother back home.

**PRIOR CONTACTS**

I checked our WAPD local contacts to see if there have been past calls involving Rachel L.Alvey. The last contact with Rachel was in November of 2012 when she flagged down an officer because her son, Joseph, was refusing to go to school in Milwaukee. Refer to update 12-050864. The only other contact with Rachel was in 2007 where she was a contact in a forgery case. I ran Rachel's information through NCIC and DOT. Her arrest history includes battery and controlled substance arrests, but these were from several years ago. She has a valid driving status. I also checked for past contacts with Joseph Alvey, but none were located other than the school incident from 2012.

According to CCAP, in August of 2011, divorce proceedings began between Rachel Alvey and Michael A. Alvey. I checked for Michael Alvey's information in Accurant and was able to locate a date of birth of 06/10/65 at the address of 2806 S. 49 St. in Milwaukee. I checked WAPD local contacts for Michael Alvey and there was only one prior contact in 2007 where he was the complainant in a

suspicious activity call. I ran Michael's information through NCIC and DOT and his arrest history includes violation of a harassment restraining order, prowling, possession of marijuana, disorderly conduct, resist/obstruct an officer, theft, criminal damage, and forgery. His last arrest was in 2011 and he has a valid driving status.

CONTACT WITH THE BUREAU OF MILWAUKEE CHILD WELFARE

On 10/01/13 at approx. 1020hrs. I called and reported this incident to "Sandra" at the Bureau of Milwaukee Child Welfare. She said the call would be entered into their system for screening.

On the morning of 10/02/13 I recieved a message from the BMCW asking to contact initial assessment social worker Jessica Bater at 322-5207 in regards to this case. At approx. 0925hrs. I called Bater back and received her voice mail. I left her a message with my contact information.

Later that afternoon I received a message back from Bater asking about WAPD's prior contacts with this family. I called her back at approx. 1635hrs. and left her a message stating that we had limited contacts with them and no contacts involving child abuse or neglect.

CASE DISPOSITION

Since the family resides in Milwaukee and Rachel Alvey was already issued a citation for Contributing to the Delinquency of a Child, it was determined that any additional follow up would be conducted by the Bureau of Milwaukee Child Welfare. There is no indication that Joseph Alvey is in any danger at this time and the BMCW will conduct follow up.

This case can be considered closed due to the arrest of an adult made by the responding patrol officers.
