NEWLY ENACTED OR DINANCE Please take notice that he City of West Allis enacted Ordinance No.

O-2012-0036, Ordinance to amend Section 12.40(2) of the Revised Municipal Code to permit collocation/attachment of telecommunication equipment to existing structures within the Central Business District as a Special Use, on September 24, 2012.

Verizon Wireless currently maintains telecommunication equipment on the rooftop penthouse of the West Park Place building at 7400 W. Greenfield Ave. Prior to the passage of this ordinance, the C-1 Central Business District did not permit collocation/attachment of telecommunication equipment (unlike other commercial zoning districts).

The applicant requested to swap the existing antennas for new equipment (a one-for one replacement). An ordinance amendment was recommended that Verizon Wireless request an ordinance amendment prior to conducting the upgrade/swap of existing for new antenna equipment on the West Park Place building at 7400 W. Greenfield Ave.
