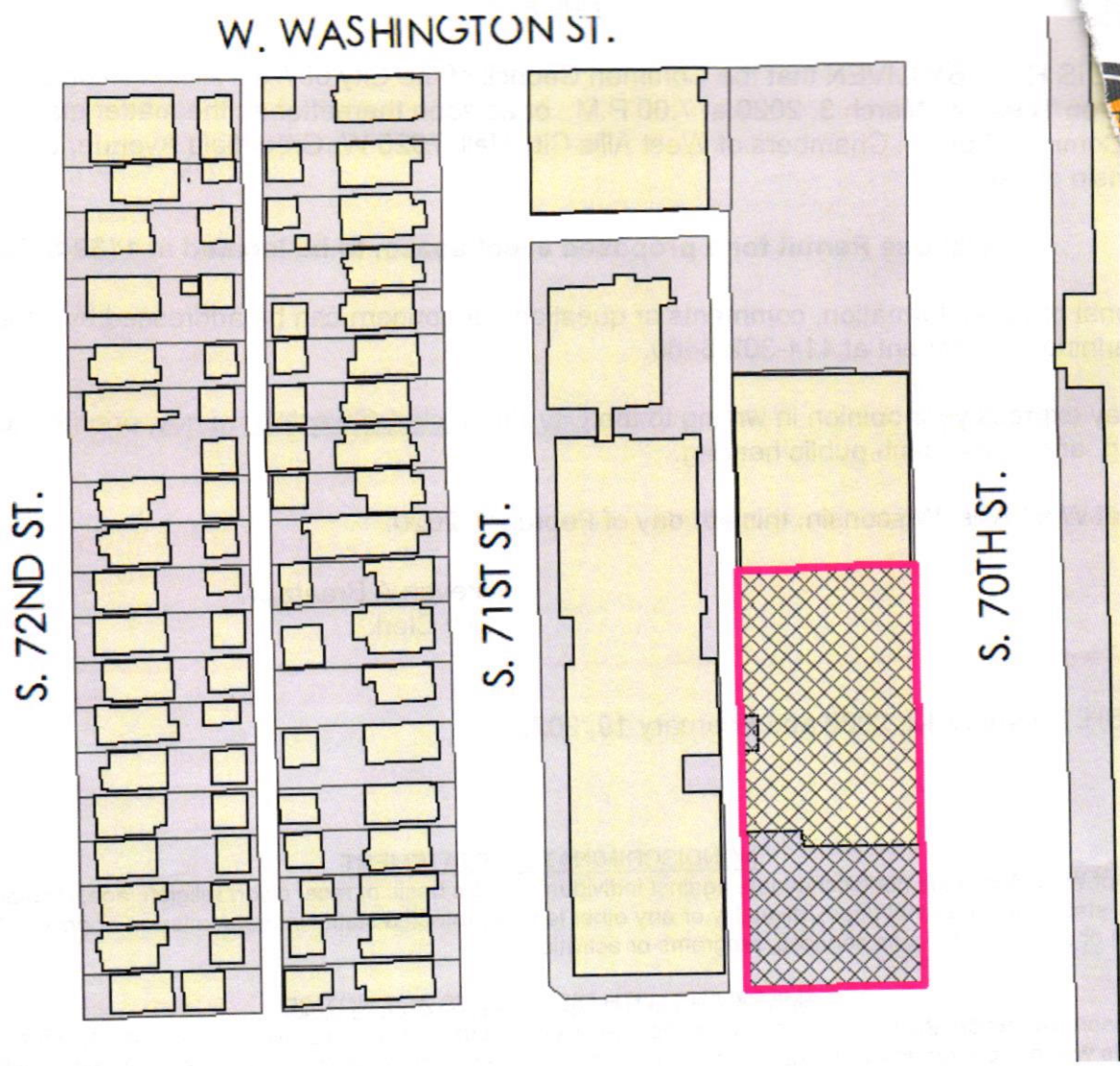
AMERICANS WITH DISABILITIES ACT NOTICE
