### SUMMARY

Officer Otto reports: Disorderly Conduct, GR's National Pub, 6827 W. National Ave.  
 On 6/9/13, at approx. 2345hrs, Officers responded to the above address for 2 male hispanics causing a problem. Upon arrival, contact was made with the caller, Sarah Denoble, (f/w, 2/8/88) who stated 2 male hispanics, one wearing a blue shirt and the other wearing a green soccer shirt had been causing problems inside the bar and refused to leave. Prior to leaving the bar, one of the males made reference to a drug cartel and made a gun with his hands. These two parties, later identified as Joel B. Beltran-Coyolt, (m/u, 11/11/88) and Jesus NMI Mazaba-Campechano, (m/u, 10/13/85) were later located at the Dog House. Officers responded back to GR's Pub and they advised they did not want them arrested, but just to stay away from the establishment. Both parties were highly intoxicated and did not understand

INITIAL RESPONSE

Lt. Johnson requested that I complete a report for the incident that occurred on 6/9/13 at approx. 2345hrs. On 7/9/13, at approx. 2333hrs I responded back to GR's National Pub to speak with the initial caller.

CONTACT WITH SARAH DENOBLE/SARAH M. REEVES-CALLER

On scene, I spoke to Sarah Denoble, who stated she is currently going through a divorce and changing her name back to Sarah M. Reeves. Sarah is a bartender at GR's National Pub. Sarah stated that on the night of the incident the two parties, later identified as Joel B. Beltran-Coyolt, (m/u, 11/11/88) and Jesus NMI Mazaba-Campechano, (m/u, 10/13/85) were inside of GR's National Pub and were bothering patrons inside of the bar. The parties were getting close to another

female in the bar and had begun touching her arm. They also began speaking to another male that was in bar who told them that he did not want to talk.

After Sarah noticed that the two people Joel and Jesus were bothering did not want them near or talking to them, she noticed that the bartender that night, Nancy, had begun talking with Joel and Jesus and had asked them to leave. At one point, either Joel or Jesus had taken their sweatshirt off and began swearing at Nancy, telling her and the patrons in the bar, "fuck you". Because Nancy was dealing with Joel and Jesus, Sarah decided to call the WAPD for assistance. Sarah was not working the night of the incident, but was a visiting.

Sarah advised that the two parties have not been back to the establishment since the incident occurred.

I asked Sarah if Nancy, whom was working on the night of the incident, was working tonight and she advised that she wasn't.

#### BARTENDING LICENSE

Sarah is a licensed bartender through the city of West Allis. Her card lists the name of Sarah M. Reeves and her bartending license number is 14-264. The card was issued on 7/1/13 and expires on 6/30/14.

#### LOCATION OF JOEL AND JESUS

On the night of the incident, Sarah and I responded to Studs Pub to see if the parties were inside, in which they werent. The bartender at Studs Pub advised that the parties were there prior to our arrival. While at Studs Pub, Jesus and Joel were being loud and disruptive, but had since left.

Officer Binter, Officer Dobschuetz, and I responded to the Dog House tavern where we located Joel and Jesus. Officers escorted both parties outside and began speaking with them. Both parties advised that they did not speak english, therefore Officers did the best we could to explain to them that they were not welcome back at GR's National Pub anymore.

Officer Binter and Officer Dobschuetz transported Jesus to the WAPD sub-station for a fast track identification as he could not provide any identification on scene.

#### RELEASE OF OFFENDERS

After locating Joel and Jesus, I responded back to GR's National Pub and spoke with Nancy and Sarah who advised they did not want Joel and Jesus arrested for disorderly conduct, but instead just want them to stay away from the establishment. Joel and Jesus were both advised to stay away from GR's, but still
