License and Health Committee recommends suspending the Class B Tavern License and Public Entertainment Premise License for 30 consecutive days.

**The License and Health Committee members recommended issuing Kane's Bar & Grill a warning subject to the condition if there are any drug related calls, incidents, activity for the remainder of this licensing period swift action will be taken.**

3. [2022-1083](#) Findings of Fact, Conclusions of Law and Recommendation in the matter of the complaints against Kane's Bar and Grill, 6922 W. Orchard St. Agent Edward Jones. No discipline is recommended at this time. Licensee notified that drug activity will be addressed with new enforcement action, work to abate noise issues and comply with other local, state and federal regulations.

**The License and Health Committee members recommended suspending Limanski's Class B Tavern License and Premise Entertainment Permit for 30 days.**
