**RESOLUTION APPROVING AN AGREEMENT WITH THE MILWAUKEE
METROPOLITAN SEWERAGE DISTRICT (MMSD) FOR REIMBURSEMENT OF
UP TO \$56,500 THROUGH THE MMSD GREEN SOLUTIONS PROGRAM FOR
THE INSTALLATION OF TREES IN 2026**

WHEREAS, Wisconsin Statues Section 66.0301 authorizes any municipality to enter into an intergovernmental cooperation agreement with another municipality for the furnishing of services; and,

WHEREAS, the City of West Allis recognizes the importance of green infrastructure for managing storm water in a sustainable manner; and,

WHEREAS, the City plans to purchase approximately 570 trees at a cost not to exceed \$56,500 as part of the 2026 tree planting schedule; and,

WHEREAS, the trees will be installed in the public right-of-way to capture and retain approximately 14,250 gallons of stormwater; and,

WHEREAS, MMSD will provide reimbursement to the City not to exceed \$56,500 for the planting of trees through their Green Solutions Program;

NOW THEREFORE, be it resolved by the Common Council of the City of West Allis that the City Engineer is directed to enter into the Green Solutions Funding Agreement G98005P186 (“the Agreement”) with MMSD for the planting of trees in 2026.

BE IT FURTHER RESOLVED that the Forestry Division shall perform work in compliance with the Agreement and shall maintain records documenting all expenditures made during the planting of trees in 2026.

BE IT FURTHER RESOLVED that, after completion of the tree installations, the Engineering Department shall provide a report to MMSD, as provided in the Agreement.

BE IT FURTHER RESOLVED that the City Engineer is authorized to make any non-substantive changes to the Agreement to effectuate its intent and to prepare and deliver any other documents necessary to complete the approved transaction.
