SUMMARY

On 12/06/2019 at 2052 hours, I responded to Dopps Bar, located at 1753 S. 68 St. for a report of two males fighting in the street. Investigation revealed Jefferson D. Harris (M/W [REDACTED]), was reportedly intoxicated and instigating an altercation with Jason T. Hallman (M/W [REDACTED]), and his fiancé, Jennifer S. Matthaeus (F/W [REDACTED]), while inside the bar. Impartial witnesses reported that Harris intentionally punched Hallman from behind. Angela L. Etzel (F/W [REDACTED]), removed Harris from the bar who initially left the scene in a red Jeep Cherokee. Hallman and Matthaeus exited the bar to smoke a cigarette when Harris returned in his vehicle and attempted to fight Hallman again. At approximately 2240 hours, Waukesha County Sheriff's Office advised that they responded to Harris' residence after Harris' roommate requested an ambulance due to his injuries. Harris will be mailed a citation for Disorderly Conduct.

On 12/06/2019 at 2052 hours, I, (Officer Behnke), responded to Dopp's Bar, located at 1753 S. 68 St. in the City of West Allis, for a report of a fight between two males in the street. One of the subjects fled in a red SUV northbound on S. 68 St.

I arrived on scene and spoke with a male and female outside of the bar. I observed the male to be holding his head and touching his face as though he were injured. They were identified by WI ID as Jason T. Hallman (M/W [REDACTED]) and his fiancé, Jennifer S. Matthaeus (F/W [REDACTED]).

CONTACT WITH JASON HALLMAN

I spoke with Hallman who stated he was assaulted, without provocation, by an unknown male subject, while in the bar. Hallman declined medical attention. Hallman stated there were no conflicts between him and the other male and he did not know why this male assaulted him. Hallman stated the subject left the bar and while Hallman exited to have a cigarette outside, the male returned, confronted him and the two began to fight again. Hallman stated he acted in self-defense of the subject.

Hallman was vague with his responses and was adamant he did not want to pursue any charges. I observed Hallman to appear highly intoxicated as well.

CONTACT WITH JENNIFER MATTHAEUS

I spoke with Matthaeus who stated she and Hallman were seated at the bar when an unknown subject approached Hallman from behind and intentionally punched Hallman to his back. Matthaeus stated Hallman stood up to confront who struck him and the two began to push and shove each other. Matthaeus stated the bartender, identified as Angela L. Etzel (F/W [REDACTED]), directed the other male subject to leave the bar which he did.

Matthaeus stated once they saw the other male leave, they went outside to smoke a cigarette. A few minutes later, the male subject returned in a red SUV, exited and immediately confronted Hallman to fight him again. Matthaeus stated Hallman and the other male began to fight again and the other male left in the red SUV northbound on S .68 St. Matthaeus stated the other male appeared highly intoxicated and drove recklessly at a high rate of speed as he left.

CONTACT WITH ANGELA ETZEL

I spoke with Angela L. Etzel (F/W [REDACTED]) the bartender, who stated she witnessed the incident and called the police. Etzel stated Hallman and Matthaeus were seated at the bar and there were no issues. Etzel stated that without provocation, a subject, later identified as Jefferson D. Harris (M/W [REDACTED]), approached Hallman from behind and intentionally punched him somewhere to the back

or head. Etzel stated Harris is the boyfriend to another bartender named Tracey Lynn Hinzpeter (F/W [REDACTED]), and that Etzel knows Hinzpeter's boyfriend as "Jefferson Harris".

Etzel state Hallman turned around the two began to push and shove each other. Etzel stated she told Harris to leave the bar at which time she locked the door behind Harris as he left. Etzel stated she went outside with Matthaesus and Hallman a short while later when Harris returned in a red Jeep SUV. Etzel stated Harris exited the vehicle, charged at Hallman again, and Hallman defended himself again by punching and striking Harris to the head.

Etzel stated Harris left in his red Jeep SUV at a high rate of speed and drove recklessly northbound on S. 68 St. towards W. National Ave.

I requested to review the surveillance for this incident however Etzel did not know how to operate the camera system. Etzel requested I come back on a later date.

LACK OF CONSENT

Etzel stated no one had permission to cause a disturbance in the bar. Etzel stated she would be a complainant in the matter.

IDENTIFICATION OF SUSPECT

At approximately 2240 hours, I was contacted by Waukesha County Sheriff's Office Deputy Moose who advised she responded with an ambulance to a request for an ambulance at Jefferson D. Harris (M/W [REDACTED]) residence. Deputy Moose advised that Harris' roommate called to request an ambulance after Harris returned home and had visible facial injuries. Deputy Moose advised that Harris stated he was in a bar fight at Dopps' Bar in West Allis.

Deputy Moose advised that Harris may have a concussion and was being transported to Froedert Hospital. I asked Deputy Moose to advised Harris that if he wanted to make a complaint, he can report to me at the West Allis Police Department. Deputy Moose provided me with their incident report number (#W19-090678) and agreed to advised Harris of my request.

ISSUANCE OF CITATION

I mailed Jefferson Harris citation # 1S804D2ZBS for Disorderly Conduct with a non-mandatory court date of January 27, 2020 a 0830 hours.

FOLLOW-UP AT DOPPS

On 12/10/2019 at 1957 hours, I followed-up at Dopps bar and spoke with Tammy L.
