**NARRATIVE**

INITIAL RESPONSE

On 11/19/14 at approx. 2335hrs. Officers responded to Las Palmas, 6007 W. Burnham St, for a male party banging on the doors and windows. Officer Stuetzgen arrived on scene first and made contact with the intoxicated and argumentative Gary M. Steffens M/W 03/29/54 while I made contact at the tavern.

STATEMENT OF CAYETANO NMI ANTONIO RIVERA

Cayetano NMI Antonio Rivera M/H 08/08/76 who is the owner of the business stated at approx. 2300hrs. Gary came into the tavern. Cayetano stated there was a African American couple also in the tavern who were sitting at a table on the S/E corner. Cayetano stated the couple bought Gary a drink as he was hanging around them and bugging them. Cayetano stated Gary then sat at the bar away from the couple drinking the drink they purchased for him and there were no problems for awhile.

Cayetano stated out of nowhere Gary flipped out and began knocking chairs and tables over before proceeding to pour his drink out on the ground and act like he was going to throw it at the African American couple. In the process of doing so, Gary was yelling racial slurs at the African American couple which included calling them, "Niggers." Cayetano stated the male took offense to what Gary was saying and escorted him out of the bar. Cayetano stated Gary was only pushed out and had no idea how he suffered the head injury. Cayetano believed he may have fell at some point due to his intoxication.

Cayetano stated Gary returned shortly thereafter and was banging on the doors and windows as they had locked him out. Cayetano stated Gary then walked away and within minutes the WAPD arrived on scene. Cayetano stated he did not call the Police because once Gary left, the Police arrived on scene.

## NARRATIVE

## CALL INFORMATION

On 11/19/14 at 2335hrs. officers responded to Las Palmas at 6007 W. Burnham St. for male outside pounding on the door and windows of the business. Dispatch provided a description of a 50 year old male wearing an orange hooded sweatshirt.

## CONTACT WITH GARY M. STEFFENS M/W 03/29/54

I was already in the area and observed the described male outside of Las Palmas. His actions were extremely animated as he was throwing his arms up in the air and I observed him pound on the window to Las Palmas several times. I was traveling westbound and drove past the subject and turned around to create greater space based on his actions.

I made contact with the male who identified himself verbally as Gary M. Steffens M/W 03/29/54. Steffens was bleeding from his head and refused medical attention. I asked Steffens what had happened and he stated "That nigger in there punched me," indicating toward Las Palmas. I asked him what he did and he stated he called the guy a "nigger" and the guy punched him with his fist.

While standing Steffens, Steffens began saying "Fuck You" and "I could kick your ass." Steffens repeatedly reached into his pockets and I told him not to. I had Steffens turn away from me and interlock his hands on his head. Based on Steffens demeanor toward me, I grabbed ahold of his hands and performed a pat down of Steffens, finding nothing.

During my pat down, Steffens continuously stated to me and other officers on scene that he could kick our asses and that MPD officers were nice guys and we were "Mayberry pussies." As I continued holding Steffens hands together and he began stating I was hurting him and went down to his knees and layed on his back. Steffens layed down and remained on his back holding his own hands on his head.

I requested an ambulance for Steffens based on the extent of his head injury and the continuous bleeding. While laying on his back, Steffens continued stating that he could kick our asses and made motions with his hands and feet as though to punch and kick. Based his threats and actions, Steffens was rolled over and handcuffed for the safety of officers and paramedics. When the paramedics arrived, Steffens was assisted into the ambulance.
