Michael J. Czaplewski, being duly sworn, on oath deposes and states as a complaint against Colleen Doolan as follows:

1. That the complainant is a resident of the City of West Allis, is the duly elected Alderperson for the First Aldermanic District in the City of West Allis, is the chair of the License and Health Committee, and makes this complaint at the direction of the License and Health Committee of the West Allis Common Council.
2. That the information contained in this complaint comes from the complainant's review of official records maintained by the City of West Allis and the Wisconsin Department of Transportation, which records complainant believes to be reliable and accurate.
3. That Colleen Doolan is the holder of a operator's license, License No.15-442, to sell/serve alcoholic beverages under Chapter 125, Wis. Stat., issued by the West Allis Common Council for the license period beginning July 1, 2014, and ending June 30, 2015.
4. That according to the records of the Wisconsin Department of Transportation, Colleen Doolan has been convicted of the following driving offenses:



5. That according to the records of the West Allis Police Department, on August 16, 2014, Officer Sharif Said responded to a report of a vehicle stuck on the railroad tracks in the area of South 60<sup>th</sup> Street and West Beloit Road.
6. That Officer Said's investigation revealed that Doolan had a light odor of intoxicants on her breath; red and glassy eyes; slow and slurred speech; and poor balance. Doolan admitted to drinking four tall vodka waters at Scotty's Pub. Doolan performed poorly on the standardized field sobriety tests and was arrested for operating while intoxicated. An intoximeter test revealed that Doolan's blood alcohol concentration was .11.
7. That Doolan was convicted of the operating while intoxicated offense on September 22, 2014.
8. That according to the records of the Wisconsin Department of Transportation, Doolan was charged with operating while revoked, a criminal offense in violation of Wis. Stat. § 343.44(1)(b), in Waukesha County. That charge is still pending.
9. That Colleen Doolan is a habitual law offender; does not possess the necessary qualifications to hold a license pursuant to Wis. Stat. § 125.04(5)(b); and, accordingly, these allegations are grounds for non-renewal, suspension, or revocation of her operator's license.

WHEREFORE, Michael J. Czaplewski, requests that Colleen Doolan be summoned to appear before the License and Health Committee of the West Allis Common Council to answer this complaint and, if the material allegations of the complaint are denied, that a hearing be held to determine whether the Operator's License, License No. 15-442, of Colleen Doolan should be revoked, suspended, or not renewed.
