



Disposition

Braun's Power House was found to have a bartender without a valid license with the City of West Allis. The owner, Braun, was not on scene when officers arrived, but responded approx 20 minutes later. Braun and Falendysz were very cooperative with officers on scene. Braun and Falendysz will be cited by mail. A tavern violation report was also completed. This report will be sent to the C.O. for review.
