During the 4th quarter the WACCC was heavily involved in holiday programming. They covered the Christmas parade, choir concerts, events at State Fair Park, a holiday polka program and their Santa Call-in show.

The WACCC held several training workshops and sessions that were attended by 27 people. 18 new members signed up in the $4^{\rm th}$ quarter, and 56 new programs were also produced.

They held a holiday bake sale and craft fair which netted a small profit, so they will be looking to expand their efforts in 2005. The WACCC is also researching grant possibilities.

I recommend providing 4^{th} quarter funding for the WACCC.
