Alderperson Daniel Roadt of the West Allis Common Council, being duly sworn on oath, deposes and states as a complaint under Wis. Stat. § 125.12(2)(ag) against Katherine Wisniewski for her current 2022-2024 Operator's License as follows:

- 1. That the complainant is a resident of the City of West Allis.
- That this complaint is based upon personal knowledge and records maintained by the City of West Allis that the complainant has used in the past and found to be reliable.
- 3. That Katherine Wisniewski currently holds an Operator's License issued pursuant to Wis. Stat. § 125.17, issued under license number BART-513 valid through July 1, 2022, to June 30, 2024.
- 4. That Katherine Wisniewski appeared in front of the West Allis Public Safety Committee on April 18, 2023, where she was approved for the Operator's License BART-513.

- 5. That at said appearance on April 18, 2023, in front of the Public Safety Committee, Katherine Wisniewski had either a suspended or revoked driver's license. When asked about how she arrived at the meeting, Katherine Wisniewski stated that she had been given a ride to the meeting from her boyfriend and she did not drive to the meeting and her boyfriend would be picking her up as well. This statement was recorded and is publicly available on the City of West Allis YouTube page under "4-18-2023 Public Safety and Public Works Committee Meetings."
- 6. That the West Allis Information Technology department reviewed surveillance videos from the April 18, 2023, Common Council Meeting and provided said videos to the complainant regarding Katherine Wisniewski. Surveillance video from the exterior of West Allis City Hall shows Katherine Wisniewski driving and parking a dark colored sedan type vehicle to the meeting. It is further believed that Katherine Wisniewski also drove herself away from the meeting in that same vehicle.
- 7. That pursuant to Wis. Stat. § 125.12(2)(ag), the Operator's license issued to Katherine Wisniewski is subject to suspension or revocation for providing false statements to the common council or committee thereof in violation of West Allis Municipal Code §9.49(6), a municipal regulation adopted pursuant to Wis. Stat. §125.10, and violating Wis. Stat. § 125.12(2)(ag)1.

The West Allis Public Safety Committee convened on December 18, 2023, at approximately 7:00 PM, for a hearing pursuant to Wis. Stat. 125.12(2) to determine whether the Operator's License issued to Katherine Wisniewski, under license number BART- 513, should be suspended or revoked based on the allegations in the complaint. The West Allis Public Safety Committee makes the following determinations:

#### FINDINGS OF FACT:

- 1. That Katherine Wisniewski was provided a copy of the summons and complaint in this matter on April 27, 2023.
- 2. That Katherine Wisniewski appeared, as summonsed, at the May 2, 2023, Public Safety Committee where Katherine Wisniewski denied receiving the complaint, despite being present at the meeting as summonsed, and was provided a physical copy of the complaint by Attorney Kail Decker. Katherine Wisniewski denied the allegations in the complaint and requested a hearing.

- That Katherine Wisnieski was sent notice to appear at the Public Safety
   Committee Meeting on July 17, 2023, yet Katherine Wisnieski failed to appear and the matter was rescheduled.
- 4. That once again Katherine Wisniewski was summonsed to appear for the Public Safety Committee Hearing on December 18, 2023. The West Allis Clerk's office sent notice of the hearing to the physical address provided by Katherine Wisniewski on her license application and to the email address provided by Katherine Wisniewski's license application.
- 5. That Katherine Wisniewski did not appear for her scheduled hearing on December 18, 2023.

#### **CONCLUSIONS OF LAW:**

- 1. That Pursuant to Wis. Stat. § 125.12(2)(b)1. that if the licensee does not appear as required by the summons, that the allegations of the complaint shall be taken as true.
- 2. That the Public Safety Committee finds that Katherine Wisniewski was properly served with a copy of the summons and complaint on two occasions and had denied the allegations in the complaint.
- 3. That the Public Safety Committee finds that Katherine Wisnieski was sent properly noticed of the hearing date on December 18, 2023, and failed to appear for that date.
- 4. That the Public Safety Committee finds the allegations in the complaint as true and sufficient to justify revocation of the license, pursuant to Wis. Stat. § 125.12(2)(b)1.

5. That Katherine Wisniewski did violate Wis. Stat. § 125.12(2)(ag)1 and West Allis Municipal Code § 9.49(6) for making false statements to the Public Safety Committee to help induce approval of her license.

#### **RECOMMENDATION:**

Therefore, the Public Safety Committee recommends to the Common Council of the City of West Allis that the Class D Operator's License BART – 513, issued to Katherine Wisniewski, should be revoked.

Corporal Douglas Sayeg of the West Allis Police Department, being duly sworn on oath, deposes and states as a complaint under Wis. Stat. § 125.12(2)(ag) against ODD-E's Pub L.L.C. doing business as "Odd-E's Pub" as follows:

That this complaint is based upon information contained within official records
maintained by the City of West Allis and the City of West Allis Police Department that
the complainant has used in the past and found to be reliable.

#### Parties, License, and Permit Information

- 2. That the complainant is a resident of the City of West Allis.
- 3. That ODD-E's Pub L.L.C., doing business as "Odd-E's Pub" has been issued a "Class B" intoxicating liquor license and a Class "B" fermented malt beverage license (together identified on the license as a "Class B Tavern License"), and a Public Entertainment Permit, all issued under lice2023,number ALC-23-8, for the premises located at 8812 W. Greenfield Avenue in the City of West Allis, State of Wisconsin, for the license period running July 1, 2023 to June 30, 2024.

4. That Adi Sarkanjac is the agent appointed pursuant to Wis. Stat. § 125.04(6)(a) for license number ALC-23-8.

#### Incidents Subject to Complaint

Count 1: July 1<sup>st</sup>, 2023.

- 5. That on July 1, 2023, the first day of the current license period, West Allis Police were dispatched to Odd-E's Pub at approximately 2:22 AM regarding multiple subjects from the bar that were fighting in the street. Police arrived on the scene and began to break up the fight and further investigate the incident. Despite the police on scene, the subject in the fight continued to be argumentative, boisterous, and profane.
- 6. Police reported that Adi Sarkanjac, agent for Odd E's Pub, assisted police in obtaining surveillance footage which showed the fight had started within the bar when a patron threw a drink into the bartender's face. That original patron was removed from the bar and her associates were also told to leave. While removing the two associates, one of them struck a bar employee before being physically removed. Police reported that once the three aggressors had exited the bar, they were confronted by a different bar employee. This secondary confrontation apparently devolved into a physical fight in the street between all parties.
- 7. That police officer Lete Carlson reported that the primary offender who had originally thrown the drink and had engaged in the physical fight outside appeared to be very agitated and intoxicated during her contact with police.

Count 2: July 8, 2023.

8. That on July 8, 2023, Officer Sadvick was dispatched to Odd-E's Pub at approximately 11:30 PM for a report of an overdose. When Officer Sandvick investigated the concern, he determined that the subject in question had not overdosed on drugs but had instead consumed too much alcohol and had fallen over while at the bar. She was turned over to paramedics and transported to the hospital.

Count 3: September 10, 2023.

- That on September 10, 2023, at approximately 1:45 AM, the West Allis Police
   Department was dispatched to a "shots fired" complaint at Odd-E's Pub.
- 10. That Officer Hayner reported that through his investigation, he learned that the shooter had been at a few bars throughout the night before ending up at Odd-E's Pub where he continued to drink more alcohol and "get drunk." Investigation revealed that the shooter eventually left the bar and as he drove away, fired shots from his handgun at the bar at least two times.
- 11. That Officer Sandvick obtained a copy of the surveillance video from the bar that shows a black four-door sedan turning out from 89<sup>th</sup> street onto W. Greenfield avenue. The sedan accelerated rapidly and muzzle flashes are seen firing towards Odd-E's causing a patron out front to duck and yell at the vehicle.
- 12. Officer Brockmann reported that he spoke with an employee the bar, identified here as O.Z. who was reportedly was outside the bar at the time of the shooting. O.Z. reported that he saw a male (later identified as the shooter) exit the bar and briefly argue with a few other males standing by their motorcycles in front of the bar. This subject then proceeded to his vehicle and drove past the bar at which time he fired at least two gunshots from his vehicle as he drove by the bar.

13. Police did catch the shooter after a brief fleeing incident and resistive episode. In the vehicle police found the firearm used in the shooting, as well as marijuana and cocaine.

#### Count 4: September 23, 2023.

14. That on September 23, 2023, Officer laquinta was dispatched to Odd-E's Pub at approximately 2:02 AM for a report of multiple people fighting in the roadway. Officer laquinta reported that this fight apparently was resolved prior to his arrival, but the officer did speak with the bouncer at the bar, D.A., who apparently confirmed that a fight had occurred but reported that all the problem parties had left the area before officers arrived and there was no further assistance needed.

#### Count 5: October 21, 2023.

- 15. That on October 21, 2023, West Allis Police Officers were dispatched to Odd-E's Pub at approximately 1:54 AM for a report of a shooting. Police arrived on scene and made contact with two extremely intoxicated and uncooperative parties. Police attempted to determine what had occurred and were given partial information about a shooting that took place outside the bar after a large group had been fighting within the bar.
- 16. Officer Schenk reported that he spoke with Odd-E's security guard, S.M. who reported that two males got into a fight within the bar and were physically thrown out of the bar.
- 17. Officers were able to obtain external camera footage of the incident which depicted two individuals fighting outside of the bar. One individually appears to recover a

- firearm and strike the other male with the firearm several times before potentially firing a shot at the victim.
- 18. Officer Cooper reported that based on the police investigation, he was able to locate the individual who was believed to be the victim of the shooting, identified as D.H. D.H. was located in a residence adjoining the bar. D.H. originally denied any involvement in the altercation and Officer Cooper reported that D.H. appeared to be intoxicated at the time of his interactions. D.H apparently did not exit his residence to continue his interaction with police and police terminated their contact at that time due to his insistence that he was not involved in an altercation.
- 19. Police were notified later that morning that a shooting victim had checked into a nearby hospital and was believed to be from the above incident. Officer Foy reinitiated contact with D.H. at the hospital later that same morning. D.H. was in fact shot in the leg earlier during the bar fight, although he originally denied any such involvement. D.H. continued to be uncooperative with police at the hospital and claimed to not remember much of the incident because he was "drunk" at the time.

#### Violations of State Law and Local Code

- 20. That the "Class B" intoxicating liquor license and a Class "B" fermented malt beverage license (together identified on the license as a "Class B Tavern License"), issued to ODD-E's Pub L.L.C., are subject to suspension or revocation for any of the following:
  - A. Violating Wis. Stat. § 125.12(2)(ag)2 related to counts 1, 3, 4, and 5 for keeping or maintaining a disorderly or riotous, indecent or improper house

that has been the subject of several physical fights, disorderly patrons, and two separate shooting incidents within a four-month period.

- B. Violating Wis. Stat. Wis. Stat. § 125.07(2)(a)(2), per Wis. Stat. § 125.12(2)(ag)1. related to counts 1, 2, 3, and 5 for selling, dispensing, or giving away alcohol beverages to a persons who are intoxicated.
- 21. That the Public Entertainment Permit issued to ODD-E's Pub L.L.C. is subject to suspension or revocation pursuant to West Allis Municipal Code §§ 9.51(1)b. and 9.51(1)d. because the operator has failed to maintain order on the premises and has caused a public nuisance at the property, demonstrated by the repeated bar fights, two shootings, and repeated police interactions with patrons of the bar who are apparently intoxicated based on trained officer observations.

WHEREFORE, Corporal Douglas Sayeg requests that the licensee named herein, ODD-E's Pub L.L.C., be summoned to appear before the Public Safety Committee of the West Allis Common Council to answer this complaint and, if the material allegations of the complaint are denied, that a hearing be held to determine whether the licenses and permits issued to ODD-E's Pub L.L.C. should be revoked or suspended.

**WHEREAS**, the City has identified the 3 acres of land consisting of 8530-56 W. National ("Property") as eligible for an US. EPA Brownfields Revolving Loan Fund (RLF) Loan due to known environmental contamination and required cleanup; and,

**WHEREAS**, the 3LP West Allis, L LC (the "Developer") has acquired the Property for the development as part of a redevelopment Project and will be eligible for the RLF Loan; and,

**WHEREAS**, the City approved a \$500,000 RLF to the development remediation on the Property under Resolution 2023-0618; and,

**WHEREAS**, the Developer has indicated that the multiple lenders providing the financing on the construction of the project have requested that the City's loan condition of having a subordinate mortgage on the property be removed as a condition; and,

**WHEREAS**, the Economic Development Program team supports the removal of this condition to advance the over \$68 million development.

Dear Three Leaf Partners - 3LP West Allis LLC:

Pursuant to your application and information provided by you, the Common Council of the City of West Allis ("City") hereby agrees to make a West Allis Brownfield Revolving Loan Fund Ioan to 3LP West Allis LLC in accordance with the federal U.S. Environmental Protection Agency regulations and the following specific terms and conditions:

- 1. <u>Borrower.</u> The Borrower shall be 3LP West Allis LLC with offices at the property located at 504 W. Juneau Avenue, Milwaukee, WI 53203
- 2. Owner. 3LP West Allis LLC
- Guarantor: 3LP West Allis LLC
- 4. <u>Project</u>. Loan proceeds are to be used to reimburse Borrower for costs incurred by Owner for environmental work associated with the site capping, grading and soil management. Funds will be associated with work at the following properties:
  - A. Site located at 8530-56 W. National Avenue, West Allis, WI, 53214 (Tax Key # 478-9998-003). (3.19 acres)
- 5. <u>Loan Amount</u>. The loan amount shall not exceed Five Hundred Thousand Dollars (\$500,000). Disbursement of the aggregate principal will be at draw request & work performance. The loan is on a reimbursement basis. The loan will be evidenced by a note payable by the Borrower to the City.
- 6. Interest Rate. (To be computed on basis of 360-day year.) The interest rate shall be one and one-half of a percent (1.50%) per annum, provided that no interest will accrue for a period of 24 months following closing and will being accruing starting on the 25<sup>th</sup> month following closing. In the event of default, all unpaid principal and interest shall bear interest at the rate of eighteen percent (18%) per annum until paid.
- 7. <u>Term.</u> The term of this loan shall be ten years (120 months) with a 25-year amortization. A balloon payment will be required upon the last payment.
- 8. <u>Payments.</u> The loan will not have principal and interest payments for a period of 24 months following closing. Principal and interest payments will be required starting on the 25th month following closing.



- A. Loan will be required to be an automatic withdraw from the Borrower's account for payment.
- 9. <u>Late Charge.</u> A late charge not to exceed one percent (1%) on each dollar of each payment, which is more than ten (10) days in arrears may be collected provided that no such charge shall exceed the maximum amount which may be charged according to law.
- 10. Security. As security for the loan, the Borrower will deliver to the City:
  - A. Loan Agreement outlining the conditions of the loan including necessary environmental clean-up work to be performed for the loan funds.
  - B. A Note payable to the City of West Allis.
  - C. Corporate Guaranty from 504 W. Juneau Avenue, Milwaukee, WI 53203 and Personal Guaranty.
- 11. <u>Loan Processing Fee.</u> A non-refundable fee of Two Thousand Dollars (\$2,000) to be paid upon acceptance and delivery of this Commitment (Borrower may elect to include this fee in the terms of the note). The fee is compensation to the City for making the loan and shall be fully and completely earned upon acceptance of this Commitment by the Borrower.
- 12. Maturity Date. This loan shall mature 10 years after closing.
- 13. <u>Closing Date.</u> The loan shall close following the acquisition of the properties stated above under Section 3.
- 14. <u>Prepayment Privilege.</u> The loan may be prepaid, in whole or in part, at any time without penalty or restriction.
- 15. <u>Duns Number/Federal ID Number.</u> Borrower must provide a Duns/Federal ID Number as proof of application by closing and provide a federal identification number to the City.
- 16. <u>Match.</u> The Borrower is required to provide a 20% match of the total loan calculated at One Hundred Thousand Dollars (\$100,000.00). The Match must come from payment of West Allis Brownfield Revolving Loan Funds eligible activities.
- 17. <u>General Conditions.</u> All of the terms and conditions contained in the attached "Federal Requirements" (Attachment A) are incorporated into this Commitment and as provided in the draft attached. City of West Allis Brownfield Revolving Loan Agreement (Attachment B)
- 18. <u>Contract.</u> The work associated with these funds must follow the attached Federal Contract documents attached as Attachment C. Borrower is responsible for compliance with all necessary federal requirements.
- 19. <u>U.S. EPA.</u> The loan is subject to approval of eligibility from U.S. EPA. Borrower must comply with all necessary U.S. EPA requirements.
- 20. <u>Acceptance.</u> Except as provided in the General Conditions, this Commitment shall be deemed binding upon the City if the City receives an unqualified acceptance by the Borrower of the terms and provisions contained herein, evidenced by the Borrower properly executing this document below and delivering it to the office of the undersigned on or before September 27, 2023, along with the non-refundable loan processing fee and the written guarantee by 3LP West Allis LLC. If not so accepted, the City shall have no further obligation hereunder.
