Resolution establishing health and dental insurance funding levels for the plan year beginning March 1, 2015.

Chair Vitale asked for staff's follow-up report on this matter, as requested by the Committee at its February 9 meeting. Kris Moen, Finance Supervisor, presented three premium rate options for 2015: (1) Option 3A is a hybrid approach, with premiums resulting in a 5% increase for active employees and 11% for retirees; (2) Option 3B included premium increases of 2% for active employees and 15% for retirees; and (3) Option 3C included premium increases of 0% for active employees and 18% for retirees. Staff responded to questions from Committee members, including the rich benefits provided by the plan, prescription drug benefits, the number of plans the city administers for retirees, and the premiums based on actual costs for the different employee groups. Ald. Lajsic suggested a cap be placed on the premium rate paid by pre-65 retirees due to the additional information provided to the Committee. HR Director Audrey Key cautioned against that approach. Retiree Terry Morrissey expressed concern about the approach. Ms. Key explained that benefit levels were not changing. Further discussion ensued. In conclusion, the Committee voted to adopt the resolution recommending Option 3A, which includes a 5% increase for active employees and 11% for retirees.
