City of West Allis Police Officer Todd Ketterhagen reports:

LIQUOR ESTABLISHMENT VIOLATION

On 11/11/14 I conducted a tavern check at Happy Tap at 6801 West Beloit Road in the City of West Allis, County of Milwaukee, State of Wisconsin. I conducted follow up at the business shortly after the check and it was discovered that the bartender, Virginia R. Boville, f/w, 08/27/62, did not have a current license. A licensed person, Patrick J. Quigley, m/w, 05/09/50, arrived at the bar a short time later. I issued Virginia a written warning citation for 9.02(1) for operating a licensed premise without a licensed person on premises.

On 11/14/14 I spoke via phone with the owner of Happy Tap, Kim M. Caze, and notified her in regard to this.
