
WHEREAS, the Director of Development has recommended approval of the transfer of funds according to the attached budget and plan.

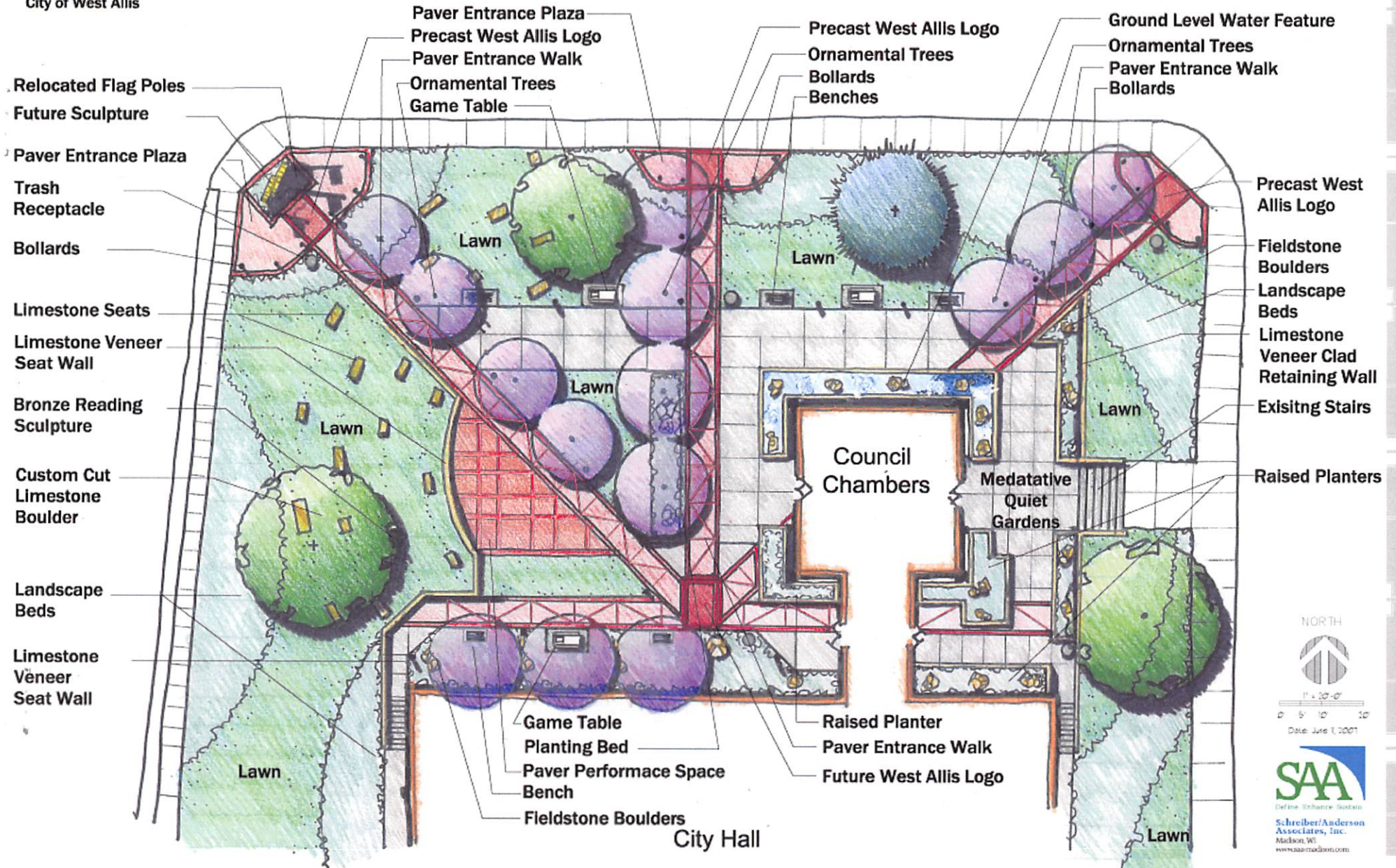
