Block: South 140' of the 1400 Block

Side: Both

Restriction: Repeal 1 Hour Parking Restrictions

PART II. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

PART III. This ordinance shall take effect and be in force from and after its passage and publication.
