**RESOLUTION TO ACCEPT THE PROPOSAL OF ARING EQUIPMENT FOR
FURNISHING AND DELIVERING ONE 2020 VOLVO EWR150E WHEELED
EXCAVATOR WITH ATTACHMENTS FOR THE TOTAL PRICE OF \$204,491**

WHEREAS, the Public Works Sanitation and Street Division has a need to replace a 23 year old Caterpillar backhoe which is at the end of its service life. A wheeled excavator is more efficient, allowing for a smaller work zone, a smaller work crew, and more safety and maneuverability in congested areas; and

WHEREAS, the Purchasing Division has reported that it has received cooperative proposals through the Sourcewell National Cooperative Contract, formerly named NJPA, Sourcewell Contract #032119-VCE for delivering one (1) 2020 Volvo EWR150E wheeled excavator with attachments for the Public Works Sanitation and Street Division of the City of West Allis; and

WHEREAS, the Fleet Services Division of the Department of Public Works has determined that this contract meets all desired specifications, and that the cooperative agreement proposal received is reasonable; and

WHEREAS, the Common Council deems it to be in the best interests of the City of West Allis that the proposal of Aring Equipment be accepted

SECTION 1: **ADOPTION** “R-2020-0692” of the City Of West Allis Municipal Resolutions is hereby *added* as follows:

BE IT FURTHER RESOLVED that the Purchasing Division be and is hereby authorized to enter into a contract for the aforesaid equipment.
