Street: W. Lincoln Avenue

Block: 8900

Side: North

Restriction: 2 Hour Parking 6:00 AM to 4:30 PM, Monday - Friday

PART II. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

PART III. This ordinance shall take effect and be in force from and after its passage and publication.


