**RESOLUTION APPROVING THE APPOINTMENT OF DANIEL R. ADAMCZYK  
TO THE POSITION OF CODE ENFORCEMENT DIRECTOR**

**WHEREAS**, the City of West Allis is committed to ensuring compliance with municipal codes, promoting public safety, and maintaining high standards of property upkeep and neighborhood integrity; and

**WHEREAS**, Daniel R. Adamczyk, a highly qualified and experienced professional, has demonstrated over 20 years of exceptional service in code enforcement, including serving as Interim Code Enforcement Director and Supervisor; and

**WHEREAS**, Mr. Adamczyk has extensive certifications and professional memberships, including UDC-HVAC, Construction, and Plumbing Inspector credentials; a Commercial Building Inspector certification; and leadership roles such as President of the Building Inspectors Association of Southeastern Wisconsin (2024–2025); and

**WHEREAS**, his professional background reflects a proven ability to lead teams, develop interdepartmental initiatives, manage nuisance abatement, oversee compliance, and foster community collaboration; and

**WHEREAS**, Mr. Adamczyk's dedication to continuous improvement is demonstrated through his achievements, such as developing a record-keeping system with OpenGov and obtaining a Certificate in Supervision from CVMIC; and

**WHEREAS**, a detailed work history highlighting Mr. Adamczyk's qualifications and accomplishments is provided in his resume, which is attached to this file; and

**WHEREAS**, the City Administrator will work on an employment agreement with Mr. Adamczyk for consideration by the Common Council at its meeting on February 11, 2025.

**NOW THEREFORE, BE IT RESOLVED**, by the Common Council of the City of West Allis:

1. The appointment of Daniel R. Adamczyk to the position of Code Enforcement Director is hereby approved, subject to the terms of an employment agreement to be reviewed and considered by the Common Council on February 11, 2025.
