Dear Mayor Devine:

I am pleased to announce that Time Warner Cable has added Azteca America channel 577 to our standard digital line up. Azteca America is the second largest producer of Spanish-language programming in the world and the fastest growing Spanish network in the United States. Its library includes hours of general entertainment, sports, movies and telenovelas programming. Azteca America is a great programming addition for Time Warner Cable Digital cable customers.

In addition beginning August 1, 2008, the monthly subscription price for the Channel Guide Magazine increased \$.05 from the current price of \$4.00 to \$4.05 at the request of the magazine publisher. Customers were notified of this increase via a message included in their guide. *Channel Guide Magazine* is a customer's best resource for making informed decisions about what to watch on television – including providing customers with the most coverage of HD programming and movies available in print.

Effective with the September billing statements the Administrative Collection Charge will increase from \$5.00 to \$6.00 per month. A bill message was included informing customers of this increase. The Administrative Collection Charge is only accessed if a customer has a past-due balance. This charge reflects the cost of collecting past due balances.

Time Warner Cable Wisconsin would like to inform you that Milwaukee Public Television recently notified us of their intention to make several programming changes to their channel offerings that Time Warner Cable will be working with MPTV to put in place early in September 2008.

These changes include:

On Monday, September 1, 2008, Milwaukee Public Television will no longer program MPTV Kids on channel 552.

On Wednesday, September 3, 2008, four channels will be added: MPTV-Digital-36 on Channel 516; MPTV Jazz (replacing MPTV Kids) on Channel 552; MPTV Weather on Channel 555; and MPTV Traffic on Channel 556.

Also on Wednesday, September 3, 2008, MPTV Extra will be renamed MPTV Classical and will remain on Channel 554.

Time Warner Cable is confident that you will agree that the MPTV changes bring added value to our valued customers.
