The library is respectfully requesting that the Purchasing Department facilitate the sole source purchase of additional LIFT audio-visual (gondola) shelving from Library Furniture International, Inc. at a cost of \$23,662.00. The LIFT shelving is only available through Library Furniture International, Inc. This shelving easily accommodates our various audio-visual materials and is ideally suited for the AV area in our library. The library is currently using LIFT gondolas for the majority of our audio-visual items (CDs, DVDs, videos).

Patron demand for audio-visual materials continues to grow at a very rapid pace, and our collection is ever increasing to meet this need. The additional shelving will provide adequate space for our current collection as well as allow for future expansion. The color will be guaranteed to match the current units.
