Dear State Dislocated Workers Unit:

Pursuant to the applicable federal and state law, notice is given of our intent to completely and permanently close all operations located at 1408 Poplar Drive, Waukesha, Wisconsin, and to permanently lay off some of our employees at 12 of our other worksites, located at the following address:

Our expected closing and layoff date will be July 1, 2008. This closing will affect between 50 and 100 employees, and the first separations of employment will commence on or about July 1, 2008. All affected employees are being offered at least 2 weeks severance pay, so no employee will have their pay discontinued prior to July 14, 2008 assuming they accept the severance offer.

The attached sheet lists the job titles that will be affected, and the approximate number of employees within those job titles who will be affected by our Plant Closing and Mass Layoff. None of our employees are represented by any union, and no bumping rights exist within our company.
