An Ordinance to Repeal and Recreate Subsections 13.28(10)(i)2. and 13.28(10)(j)2. of the West Allis Revised Municipal Code Relating to Off-Street Parking During the Wisconsin State Fair Week.

The Common Council of the City of West Allis do ordain as follows:

PART I. Subsection 13.28(10)(i)2. of the Revised Municipal Code of the City of West Allis is hereby repealed and recreated to read:

- 13.28 PROPERTY MAINTENANCE CODE.
- (10) Outdoor Areas to be Maintained. Outdoor areas shall be maintained in a clean and sanitary condition and shall not be permitted to be a blighting influence to the surrounding properties, the neighborhood or the City in general.
- (i) One and Two-Family Off-Street Parking Areas.
- 2. Parking shall not be permitted on lawn areas except that parking on lawn areas or otherwise in violation of the provisions of the off-street parking regulations of the Revised Municipal Code during the Wisconsin State Fair is allowed within the area bounded by the north City limits, South 92nd Street, South 70th Street and West National Avenue. This exception shall not apply to trailers, wagons, or other vehicles that are used to transport livestock.
- PART II. Subsection 13.28(10)(j)2. of the Revised Municipal Code of the City of West Allis is hereby repealed and recreated to read:
- 13.28 PROPERTY MAINTENANCE CODE.
- (10) Outdoor Areas to be Maintained. Outdoor areas shall be maintained in a clean and sanitary condition and shall not be permitted to be a blighting influence to the surrounding properties, the neighborhood or the City general

(j) Multi-family and Commercial Off-Street Parking Areas.

* * *

2. Parking shall not be permitted on unimproved parking or lawn areas except that parking on such areas or parking in violation of other off-street parking regulations of the Revised Municipal Code during the Wisconsin State Fair is permitted within the area bounded by the north City limits, South 92nd Street, South 70th Street and West National Avenue. This exception shall not apply to trailers, wagons, or other vehicles used to transport livestock. The parking of such livestock transportation vehicles is permitted throughout the City but only upon application to the Building Inspector and the granting of a permit to be valid only during the Wisconsin State Fair, with such terms and conditions necessary to eliminate odor, flies, blowing straw and such other negative impacts upon the surrounding area.

PART III. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby amended.

PART IV. This ordinance shall take effect and be in force from and after its passage and publication.

Please take notice that the City of West Allis enacted Ordinance No.O-2010-0021, An Ordinance to Repeal and Recreate Subsections 13.28(10)(j)2. and 13.28(10)(j)2. of the West Allis Revised Municipal Code Relating to Off-Street Parking During the Wisconsin State Fair Week, on June 4, 2010. The ordinance addresses the permitted parking on lawn areas within the boundaries of the north City limits, S. 92nd St., S. 70th St. and W. Natl. Ave. during the Wisconsin State Fair and that trailers, wagons or other vehicles that are used to transport livestock are excluded.
