The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of November.

Incident reports:

Case # 13-007731, 08/26/2013, at 0200 hrs – 6007 W. Burnham St, Las Palmas (Delayed report).

On 08/26/2013, at 2100 hrs., three parties came into the station to report an assault that occurred after they left Las Palmas, 6007 W. Burnham St. The assault occurred in the parking lot behind Las Palmas, at approximately 0200 hrs. The parties were pulled out of a vehicle and each was physically assaulted. The parties were associates of the victims and were identified. Six individuals were mailed Municipal Citations for Disorderly Conduct.

Call #13-48974, 11/01/2013, at 0159 hrs. – 1100 S. 60 St, Double Barrell

On 11/01/13, officers responded to 1100 S 60 St, Double Barrell for a weapons call. Bradley S. Davidson alleged Wade E. Holingsworth threatened to shoot him for no reason. All patrons in the bar, including bartender, Jason A. Palinski, stated Davidson started the argument, and was never threatened by anyone. Davidson was highly intoxicated, and left the scene on foot. No one at the bar wanted anything done. (Note: There was not a report generated for this incident.)

Case # 13-10005, 11/02//2013, at 2106 hrs – 6300 W. Lincoln Av, Johnny Hammers

On 11/02/2013, at approximately 2053., Officers responded to 6300 W. Lincoln Av, Johnny Hammers. Officers were clearing a call in the 2200 block of S. 62 St when they heard yelling from a block away and observed there was a verbal altercation in the beer garden of Johnny Hammers. Investigation revealed the verbal altercation involved the bartender Amanda M.

Altamore and a customer, Jennifer L. White. Both parties wanted nothing done with this and were advised to keep the noise at a reasonable level. Amanda Altamore was serving alcohol without a valid bartender's license on the premise, causing the bar to be temporarily closed. Both Altamore and Johnny Hammers license holder, Jon R. Cervantes, were cited

Case # 13-10153, 11/08/2013, at 1618 hrs – 5630 W. Lincoln Av., Bobblehedz

On 11/08/2013, at approximately 1618 hrs., Officers were dispatched to Bobblehedz, 5630 W. Lincoln Av., for a disorderly person refusing to leave the premise. Upon arrival, Officer met with bartender, Bernard B. Huber, who reported the person left prior to Officer's arrival. Bernard reported the disorderly person came into the bar and was extremely intoxicated. He was yelling at the patrons and demanded Bernard serve him alcohol. Bernard asked him to leave on several occasions and he refused. He continued to argue with Bernard and a few patrons left the bar because they were offended by his behavior. Bernard gave a description of the patron and Officers later made contact with Roger L. Thompson, who matched the description. Thompson was extremely intoxicated and yelling in the neighborhood. Thompson was arrested and booked for Disorderly Conduct.

Case # 13-10132, 11/08/2013, at 0027 hrs – 9442 W. National Av., Brooklyn's

On 11/08/2013, at approximately 0027 hrs., Officers responded to Brooklyn's, 9442 W. National Av. for a Trouble Call. Officers made contact with two patrons, identified as Anthony M. Cereceres and Peter D. Griffin, as well as, two security staff members, identified as David E. Cusiamano and Todd E. Kohler. Officer observed a strong odor of an alcoholic beverage emitting from Anthony's breath. His eyes were red and glassy, his speech was slow and slurred. The Officer, based on his observations, training and experience believed Anthony was highly intoxicated. Investigation showed Anthony was asked to leave the establishment by Brooklyn staff, but refused to comply and assaulted both security personnel. Kohler attempted to get Anthony to leave by pushing him out the door, culminating in Anthony taking his belt off and swinging it at the bouncers, hitting both of them with the belt. Kohler then punched Anthony in the face three times. Anthony was taken into custody and issued municipal citations for Criminal Trespass to a Dwelling and Disorderly Conduct.

Case # 13-10189, 11/10/2013, at 0116 hrs – 9105 W. Lincoln Av, Draft Tavern

On 11/10/2013, at approximately 0116 hrs., Officers responded to the Draft Bar, 9105 W. Lincoln Av, for a report of a physical fight. Officers located Gary Borowski just inside the main entrance door. Gary was "jumped" by three unknown male Hispanics. He was punched, pushed and kicked. Gary had abrasions to his forehead, right hip and complained of rib pain. A WAFD Med Unit was called for Gary, but Gary refused medical attention. He did not want anyone arrested over the incident, stating he would "take care of it himself." An Officer spoke with the bouncer, Karter Stank, who observed the altercation. Stank grabbed the Hispanic male and assisted the male in exiting the business. Stank advised he has had several problems in the past with the victim, Borowski.

Case # 13-10357, 11/16/2013, at 0100 hrs – 9440 W. National Av, Brooklyn’s

On 11/16/2013, at 0300 hrs., Angela Reyes Galarza and her sister-in-law, Yasel Nigaglioni came into the station to report Angela’s husband, Jordanny Reyes, choked and struck Angela during a physical altercation that occurred walking out of Brooklyn’s Gentlemen’s Club at 9440 W. National Av. This occurred at approximately 0100 hrs., Angela had a red hand print on the left side of her face and several red marks on her throat. Jordanny was picked up and arrested by Officers near his residence at 4139 S. 51 St, Milwaukee for Battery – Domestic Violence.

Case # 13-10377, 11/17//2013, at 0133 hrs – 6007 W. Burnham St, Las Palmas

On 11/17/2013, at approximately 0100 hrs., an Officer performed a traffic stop on a vehicle in the 2200 block of S. 61 St, which resulted in the arrest of the driver, Edwin R. Lopez Torres, for OWI. Further investigation revealed that both the driver and front passenger, Rosa L Sanchez Morales, were drinking at Las Palmas prior to the traffic stop. Rosa was taken into custody and cited for Underage Consumption. Officer cited Cayetano NMI Antonio Rivera and Hugo NMI Jose Juarez Municipal Citations for Permit Underage Person to Enter/Remain on License Premises.

Case # 13-10523, 11/21//2013, at 0140 hrs – 6801 W. Beloit Rd, Happy Tap

On 11/21/2013, at approximately 0140 hrs, Officers responded to the Happy Tap Bar, 6801 W. Beloit Rd for a theft call. The bartender, Stephanie M. Couillard, stated an electronic gaming machine was compromised. An unknown amount of cash was taken from the machine and the locking mechanism was compromised. Couillard said all the suspects described were surrounding the machine. No arrests were made.

Call # 13-053071, 11/30//2013, at 2244 hrs – 9105 W. Lincoln Av, Draft Tavern

On 11/30/2013, at approximately 2244 hrs., Officers responded to 9105 W. Lincoln Av, Draft Tavern, for a Disorderly Conduct complaint. Haytham A. Asad was being disorderly in the bar and was being escorted out by security. He was banned from the bar and advised not to return per the owner, Paula K. Johnson. Asad left with no problems. (Note: There was not a report generated for this incident.)

Tobacco and Alcohol Compliance checks:

- No tobacco compliance checks were conducted during this reporting period.
