RESOLUTION TO IMPOSE A TEMPORARY MORATORIUM ON INDUSTRIAL USES AT THE PROPERTIES LOCATED AT 6500 W. WASHINGTON ST., 1323 S. 65 ST., AND 1339-1347 S. 65 ST. (TAX KEY NOS. 439-0001-037, 439-0139-002, 439-0140-001)

**WHEREAS**, the City of West Allis zoning ordinance currently allows industrial uses as permitted by right or as a special use within section 12.45 of the Revised Municipal Code; and,

**WHEREAS**, the City is in the process of a zoning ordinance update and zoning map amendments; and,

**WHEREAS,** the City has no intention of permanently withholding the grant of such uses to any qualified person, but seeks only a brief and temporary interval to consider the existing zoning and future land use vision for property located at 6500 W. Washington St., 1323 S. 65 St., and 1339-1347 S. 65 St. (Tax Key Nos. 439-0001-037, 439-0139-002, 439-0140-001); and,

**WHEREAS,** it is in the City's interest to put all future permit applications for industrial uses at the properties located at 6500 W. Washington St., 1323 S. 65 St., and 1339-1347 S. 65 St. (Tax Key Nos. 439-0001-037, 439-0139-002, 439-0140-001) on hold until the further consideration by the Common Council of potential amendments to the zoning ordinance, future zoning and land use map are introduced and acted upon.

**NOW THEREFORE,** THEREFORE, BE IT RESOLVED, by the Common Council of the City of West Allis that a moratorium be imposed on the granting and issuing of all aforementioned permits for industrial uses at the properties located at 6500 W. Washington St., 1323 S. 65 St., and 1339-1347 S. 65 St. (Tax Key Nos. 439-0001-037, 439-0139-002, 439-0140-001) on hold for a period of sixty days.

**SECTION 1:** <u>ADOPTION</u> "R-2020-0548" of the City Of West Allis Municipal Resolutions is hereby *added* as follows:

BE IT FURTHER RESOLVED that the moratorium may be extended by the Common Council for up to an additional sixty days if review of the proposed ordinance is still pending or eliminate the moratorium sooner if it is no longer needed.
