RESOLUTION R-2026-5578**

**RESOLUTION TO AUTHORIZE THE PURCHASE OF ONE NEW 2026 ELGIN
PELICAN STREET SWEEPER FROM MACQUEEN EQUIPMENT FOR A TOTAL
OF \$334,489.20**

WHEREAS, the Public Works Storm Water Utility must replace a 14-year-old street sweeper (#2835) which has exceeded its service life with a more efficient and functional street sweeper to enhance the City's street cleaning program; and

WHEREAS, item #52 in the 2026 approved budget includes \$385,000 for the purchase of a new street sweeper; and

WHEREAS, a cooperative proposal through the Sourcewell National Cooperative Contract #093021-ELG has been received; and

WHEREAS, the Public Works Fleet Services Division has determined that this contract meets all desired specifications and that the cooperative agreement proposal received is reasonable; and

WHEREAS, it is in the best interest of the City of West Allis that the proposal of MacQueen Equipment be accepted.

NOW THEREFORE, be it resolved by the Common Council of the City of West Allis that the proposal dated July 23, 2026 by MacQueen Equipment for a total of \$334,489.20 is accepted.

BE IT FURTHER RESOLVED that funding for this purchase has been budgeted and is available; the purchase will be charged to Account Number 540-1801-538.70-03.

BE IT FURTHER RESOLVED that the Finance Department is authorized to enter into a contract for the aforesaid equipment.

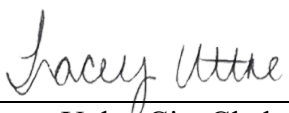

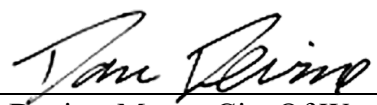
