On 06/14/18 at 0104hrs., Officers were dispatched to The Alibi Tavern for a possible assault. Officers made contact with Mitchell J Tompkins, M/W, 12/31/92, who stated he was assaulted by his father Richard L Tompkins, M/W, 07/30/70 at their residence located at 2233 S 67th Pl. Investigation revealed both parties were involved in a verbal argument, which turned physical. During the argument, Mitchell was punched in the mouth once. When officers attempted to make contact with Richard, he attempted to flee into the residence and was highly uncooperative with officers. As officers were attempting to detain Richard, an officer was bit by a dog causing minor injuries. Richard was arrested for dv/dc. He posted bailed and was released. The dog was transported and quarantined at MADACC. This case will be reviewed by the DA's office on 06/15/18 at 0830hrs.

**\*\*My department issued Axon 2 body worn camera was equipped and activated throughout the duration of this investigation. Below is a summary of this incident - refer to the video footage for full details of this case\*\***

**INITIAL CALL**

On 06/14/18 at 0104hrs., Officers were dispatched to The Alibi Tavern for a possible assault. Upon arrival, Officers made contact with a male party identified by a Wisconsin driver's license as Mitchell J Tompkins, M/W, 12/31/1992 who claimed he was assaulted by his father, Richard L Tompkins, M/W, 07/30/70.

**ON SCENE STATEMENT OF MITCHELL J TOMPKINS - VICTIM**

Mitchell stated he was at an event inside the State Fair grounds with several other family members and other family friends. They all left the event and went to the Happy Tap Tavern, located at 6801 W. Beloit Ave. Mitchell stated while at Happy Tap, he was attempting to help a friend with relationship issues. At that point, an argument began between Mitchell and his father identified by a Wisconsin driver's license as Richard L Tompkins, M/W, 07/30/1970.

Mitchell stated he left Happy Tap and returned home to his residence, located at 2233 S. 67th Pl. Mitchell stated Richard then returned home approximately 10 minutes after Mitchell arrived and started another verbal argument about Mitchell moving out of their residence. Mitchell advised Richard was threatening to kick him out of their house. Mitchell claimed that Richard had choked him in the past, but did not provide specific dates. Mitchell said that he feared for his safety and did not want to return home. He believed Richard would assault him again. Mitchell stated he then left the residence and walked to The Alibi Tavern. Richard left the residence to return to the Happy Tap Tavern.

Mitchell stated Richard was wearing a black cloth vest with a "Lone Wolf" patch on the left side of the chest. Richard has short hair, a "scruffy" beard and has on blue jeans. Mitchell stated if Richard finds out that officers are involved, Richard is going to get 10 times more angry than he already is. Officers then left to attempt to make contact with Richard while Officer Otto stayed with Mitchell.

**CONTACT AT HAPPY TAP TAVERN**

Officers arrived at Happy Tap Tavern and spoke with a bartender. She stated the tavern was closed and remembered seeing Richard inside the bar earlier in the night; however, he recently left on foot eastbound on W. Beloit Rd. Officers left Happy Tap and drove to Richard's residence at 2233 S. 67th Pl. to attempt contact.

While driving northbound on S. 67th Pl., from W. Beloit Rd., I observed multiple individuals standing in the roadway outside of the residence. Once I parked my vehicle, the individuals began to run inside the residence. I exited my squad and ran up to the residence and made contact with a male party later identified by other officers as Julio R Tompkins, M/W, 06/14/92. Julio stated Richard went inside to use the restroom. Another female who was later identified by another officer as Nicole M Rivera, F/W, 04/17/73, stated she would go inside to get Richard.

**CONTACT WITH RICHARD L TOMPKINS - OFFENDER**

Once Richard exited the south facing door of his residence, officers began speaking with Richard. Richard appeared to be intoxicated. Richard instantly became irate and began screaming, "Shut the fuck up, you are in my yard!" to officers. Due to Richard's high level of intoxication and his demeanor towards law enforcement, officers made contact with Richard and attempted to gain control of him and detain him. Before officers could detain Richard, one of his dogs exited his residence because Nicole opened the side door. The small brown pit bull ran up to Officer Kaye, who stated the pit bull bit him. See Officer Kaye and Officer Stikl's supplemental reports for further detail regarding the bite.

While attempting to detain Richard, Nicole made multiple advances toward officers who were attempting to detain Richard. Nicole was told several times to stay back, but refused to obey officer's orders. Nicole was subsequently arrested for obstructing officers. See Officer Kaye and Officer Stikl's supplemental reports for further details regarding the arrest.

Richard was escorted from the rear of his residence to the front. While attempting to detain Richard in handcuffs, he displayed resistive tension in his left arm. Eventually officers were able to detain Richard in handcuffs for this investigation. Richard was advised he was not under arrest and was only detained for the investigation.

I asked Richard what occurred between he and his son earlier in the night, which he stated, "I am going to kick his ass." Richard explained Mitchell was "hitting on" one of his sister's friends which caused Richard to become upset. Richard stated he, his son, other family and friends were at the Wednesday Night Live event at the State Fair grounds. Richard stated they left the event to go to Happy Tap for some drinks.

Richard stated while at Happy Tap, "All hell broke loose in the bathroom of Happy Tap." He stated there was not any physical fighting, only fighting via social media. Richard stated the argument began when Mitchell sent other male individuals some social media messages, which angered them. Richard did not know who the messages were directed towards. Richard then left Happy Tap and returned

to his residence to confront Mitchell. When Richard arrived at his residence, he stated an argument ensued between them.

Richard stated the argument escalated into a physical altercation. Richard claimed Mitchell punched him first above his right eye. Officers did not observe any injuries to Richard's face. Richard stated he then told Mitchell, "You are out of here, if you ain't out of here by the fucking morning I am killing you." Richard then admitted to punching the left side of Mitchell's jaw with his right hand. Richard showed officers two cuts that were on the knuckles of his right index finger and right middle finger. Richard stated the cuts were from Richard punching Mitchell. Richard said that he would not lie and that he did in fact punch Mitchell.

Richard stated after the physical altercation, he threw Mitchell out of the residence. At that point, everyone gathered outside of the residence to talk about the incident. Richard admitted that everyone ran inside when they observed officers because they knew what was going to happen to them. Richard then stated, "And me, I will pick a fight with you guys, I ain't going to lie, I would pick a fight with you guys. That is why I went inside." Richard denied being involved in any other physical altercations with Mitchell.

I asked Richard why he hit Mitchell and Richard stated it was because of the text messages that Mitchell sent out. Richard stated he was unsure of who Mitchell sent it to, but he saw it because Julio showed him. Richard stated if Mitchell returns to the residence he will punch him again. Richard continued to state that he would, "Beat Mitchell's ass."

**LACK OF CONSENT**

Mitchell did not give Richard consent to assault him or to cause him to fear for his safety.

**ARREST DECISION**

Based on Mitchell's initial 911 call advising he was assaulted by Richard and Richard's admission to punching Mitchell in the mouth, Richard was arrested for DV / DC.

Richard was searched and placed in the back of my squad car for processing at the WAPD. Throughout my entire contact with Richard, he stated in several different ways that he would cause another physical altercation with Mitchell if Richard sees Mitchell again.

**INITIAL RESPONSE**

**STATEMENT BY MITCHELL J. TOMPKINS-VICTIM**

This statement is regarding an incident that occurred on 5/28/18 while at 2233 S. 67th Pl.

Mitchell J. Tompkins, (m/w, 12/31/92), stated his father, Richard L. Tompkins, (m/w, 7/30/70), and he were at their residence which Mitchell moved into approx. one year ago. Mitchell stated and argument occurred that night but could not remember what it was about. Mitchell was in his room and his dad was in the living room. Richard began yelling to Mitchell asking where his phone was and Mitchell told him he had it in his hands. Mitchell was now in the living room and his dad was asking where the Bluetooth speaker was and it was on a table close to where Richard was sitting. Mitchell picked up the Bluetooth speaker and tossed it to his father.

After tossing the speaker to Richard, Richard yelled at him, "You have 30 minutes to get out or I am calling the Police!" Mitchell then told his father to force him to leave. Richard walked over to Mitchell and grabbed him by the neck which made it, "kind of" hard to breath and stated it felt like he was going to pass out. In order to defend himself Mitchell pushed Richard away by pushing him in his neck. This altercation lasted for approx. ten minutes and the two separated. Mitchell then tried to leave the residence in order for both of them to cool down and Richard told him that if he leaves he is not coming back.

Mitchell was able to leave the residence and approx. 30 minutes later, he received a call from Richard's girlfriend who stated that Richard had calmed down and that he could return to the residence. Mitchell came back to the residence and he and Richard had a few more words and then went to bed.

**NARRATIVE**

Ofc. Stikl reports:

My Axon Body Worn Camera was operational throughout this incident. The following is a summary of events. For a full transcript, see the video footage.

**CALL FOR SERVICE**

On 06/14/18 at 0104hrs., officers responded to The Alibi Tavern located at 6540 W. Grant St. to speak with an individual identified as **Mitchell J. Tompkins (M/W 12/31/92)**, who claimed to have been assaulted by his father **Richard L. Tompkins (M/W 07/30/70)** earlier in the night. Mitchell advised Richard was wearing a black cloth biker vest and jeans. He believed Richard walked to the Happy Tap Tavern located at 6801 W. Beloit Rd. after the altercation. Officers spoke with the bartender at Happy Tap, who informed officers that the bar had closed and they last observed Richard walking eastbound on W. Beloit Rd. Richard Tompkins currently resides at 2233 S. 67th Pl.

Officers proceeded to his residence in an attempt to make contact with Richard. As Ofc. Brockmann and I turned northbound on S. 67th Pl. from W. Beloit Rd., I observed a group of individuals standing in the street along the west side in front of the address #2233. One of the individuals within the group was an older M/W wearing a black vest and jeans matching the description of Richard. As the group of individuals recognized fully marked West Allis Police Department squads driving towards them, the group of individuals including Richard then sprinted towards the residence and entered #2233.

As officers approached the residence, I observed a M/W, identified as **Julio R. Tompkins (DOB: 06/14/92)**, and a F/W, identified as **Nicole M. Rivera (DOB: 04/17/73)**, standing on the walkway south of the residence. When asked why everyone ran into the residence, Rivera stated they ran after noticing officers in the area. Rivera then proceeded to the south entrance/exit door to the residence holding it open as Richard had exited. Rivera was advised to keep the door closed to ensure their pit bulls would not run loose causing officer safety concerns. In the past an officer had been bit by one of their pit bulls causing injuries.

As officers attempted contact with Richard, I observed a smaller brown pit bull exit the residence and run over toward Ofc. Kaye. At that point, Ofc. Kaye advised the pit bull had bit him. Eventually, the dog was contained inside the residence. As Ofc. Kaye and Ofc. Brockmann escorted Richard from the back yard and along the east side of the residence, I closed the wooden fence door. I attempted to assist officers in detaining Richard in handcuffs, but was unable

to due to Nicole's behavior. She quickly approached me attempting to make contact with Richard by walking between myself and him. I instructed Nicole to back up and had to use my arm as a barrier to keep her from walking any closer causing officer safety issues. Nicole failed to comply with my orders. I had to instruct her multiple times to back up and physically separate her from the area in order for her to comply. Based on Nicole refusing to obey officers orders and attempting to interfere with officers during an investigation causing for concern regarding officer safety issues, her behavior hindered my ability to due my job causing me to focus my attention on her rather then the person of interest in our investigation.

*Let it be noted during my contact with Nicole, I detected a strong odor of intoxicants emitting from her breath, her eyes to be red and glassy and her speech to be slurred.*

**PO Kaye Reports:**

On 06/14/15 at approximately 0104hrs, officers responded to the Alibi, 6540 W Grant St, to speak with an individual who claimed to be assaulted by his father. Officers made contact with the victim, Mitchell J. Tompkins (M/W 12/31/92), who explained he was assaulted by his father, Richard L. Tompkins (M/W 07/30/70), a week ago and was threatened by him today. Mitchell indicated he was scared to go home as he believed Richard would assault him again tonight. Mitchell advised Richard was believed to be at the Happy Tap, 6801 W Beloit Rd. See PO Brockmann's Incident Report for further information regarding Mitchell's statement.

**ATTEMPT CONTACT - HAPPY TAP**

Officers responded to the Happy Tap in attempts to locate and speak to Richard. Officers were advised by a Happy Tap employee that Richard was not at the tavern and was believed to have left approximately 20 minutes prior to officer arrival.

**FOLLOW UP - 2233 S 67 PL**

Officers responded to Richard's residence, 2233 S 67 Pl, in attempts to locate and speak to Richard. Upon my arrival, I observed a group of approximately 8 individuals congregated around a vehicle parked in front of the residence. As I approached the group of individuals in my fully marked WAPD SUV, they began to run to the rear entrance of the residence. I stopped and exited my fully marked WAPD SUV, and began to run towards the individual who fled from the street. I ordered the fleeing individuals to stop and identified myself as the Police, to which everyone failed to comply with the exception of Julio R. Tompkins (M/W 06/14/92).

I opened and entered the closed wooden gate of the enclosed yard of the residence, where I made contact with Julio. Shortly thereafter, Nicole M. Rivera (F/W 04/17/73), exited the residence, walked towards the front of the house, and was telling Julio to go inside. Julio began telling Nicole to go inside.

While on scene, I recalled an incident at this same residence where Richard

threatened to shoot Law Enforcement Officers, ran from Police, and resisted officers as well as officer being bitten by a Pit Bull.

At this point, Richard exited the rear door of the residence where I noticed Richard had some sort of holster on his right hip. I asked Richard to come over and speak with me several times to which Richard initially walked towards me, raised his arms out to the side as if he had no idea what I wanted him to do, and suddenly started to move back towards the rear door.

There were multiple individuals in the enclosed yard of the residence, all of who were yelling, arguing with officers, and moving around freely creating an unsafe/chaotic situation. Due to the fact there was no control of the situation, I attempted to utilize heavy control talk and ordered everyone to "Knock it off!" Richard immediately yelled at me to "Shut the fuck up, you are in my yard!"

Based on the fact unsafe/chaotic situation, the fact Richard was a suspect in an assault incident with Mitchell, and Richard's agitated state; I placed Richard hands behind his back and began to walk Richard to the front yard backwards - So I could maintain visual on the other individuals in the yard. PO Brockmann came to assist me. Prior to being able to turn around, Sandra S. Hayes (F/W 03/26/64), attempted to intervene with me escorting Richard from the back yard as she approached me from behind and continually told me to stop.

**Note:** While speaking with both Richard and Nicole, I detected the odor of alcohol emitting from their breath and noticed their red and glassy eyes - Nicole was so intoxicated she urinated herself. Based on my training and experience as a Police Officer, I believed Richard and Nicole to be under the influence of an intoxicant.

**DOG BITE**

While I walked Richard out of the enclosed yard a small brown/black Pit bull exited the rear door of the residence, ran around everyone towards Richard and I, and attempted to bite me from behind. The Pit bull was unsuccessful at completing a full bit, but was able to nip/pinch my upper left hamstring area with its teeth. This caused me pain and left a red mark on my leg. The dog bite did not break skin and I did not need any medical attention. I did take photographs of the injury.

**RESISTIVE EPISODE**

After the Pit bull bit me, I continued to walk Richard to the front of the residence where I stabilized Richard up against the front of the house so he could be detained. PO Brockmann started to place Richard into handcuffs where Richard display resistive tension in his arm - Low level a agitation - to which I forcibly secured Richard against the residence. While PO Brockmann completed handcuffing Richard, Nicole attempted to intervene with officers. PO Stikl had to physically move Nicole backwards and order he to back up. After Richard was

Officer Kaye advised me he was bit by a small brown pit bull mix that ran out the side door of the residence as they were attempting to detain subjects outside of the residence. Officer Kaye advised he was bit one time in the upper left hamstring area. I was unable to view Officer Kaye's injury on scene based on the injury location. It was believed that the dog that bit Officer Kaye was the same dog that bit Officer Carlson in a similar incident the previous year.

**CONTACT WITH DOG OWNER**

I spoke with the dog's owner, Sandra S. Hayes F/W 03/26/64 who was on scene. Sandra advised me that the dog's name was Spike, and that he is an approx. 3 year old brindle pit bull mix. Sandra confirmed Spike was the dog that bit Officer Carlson last year. Sandra claimed Spike was quarantined after the last incident and forced to receive the rabies vaccination. Sandra as unable to provide any documentation for the rabies vaccination.

**DOG BITE PAPERWORK**

Based on Sandra's inability to produce rabies vaccination paperwork, I completed the Dangerous Dog Order and the West Allis Health Department Rabies Quarantine Order. Copies of the forms were uploaded to the case file, and the originals were turned into the Commanding Officer. I additionally notified

**INITIAL CALL**

Upon arrival, Officers made contact with a male party identified by a Wisconsin driver's license as Mitchell J Tompkins, M/W, 12/31/1992 who claimed he was assaulted by his father, Richard L Tompkins, M/W, 07/30/70.

**ON SCENE STATEMENT OF MITCHELL J TOMPKINS - VICTIM**

Mitchell stated he was at an event inside the State Fair grounds with several other family members and other family friends. They all left the event and went to the Happy Tap Tavern, located at 6801 W. Beloit Ave. Mitchell stated while at Happy Tap, he was attempting to help a friend with relationship issues. At that point, an argument began between Mitchell and his father identified by a Wisconsin driver's license as Richard L Tompkins, M/W, 07/30/1970.

Mitchell stated he left Happy Tap and returned home to his residence, located at 2233 S. 67th Pl. Mitchell stated Richard then returned home approximately 10 minutes after Mitchell arrived and started another verbal argument about Mitchell moving out of their residence. Mitchell advised Richard was threatening to kick him out of their house. Mitchell claimed that Richard had choked him in the past, but did not provide specific dates. Mitchell said that he feared for his safety and did not want to return home. He believed Richard would assault him again. Mitchell stated he then left the residence and walked to The Alibi Tavern. Richard left the residence to return to the Happy Tap Tavern.

Mitchell stated Richard was wearing a black cloth vest with a "Lone Wolf" patch on the left side of the chest. Richard has short hair, a "scruffy" beard and has on blue jeans. Mitchell stated if Richard finds out that officers are involved, Richard is going to get 10 times more angry than he already is. Officers then left to attempt to make contact with Richard while Officer Otto stayed with Mitchell.

**CONTACT AT HAPPY TAP TAVERN**

Officers arrived at Happy Tap Tavern and spoke with a bartender. She stated the tavern was closed and remembered seeing Richard inside the bar earlier in the night; however, he recently left on foot eastbound on W. Beloit Rd. Officers left Happy Tap and drove to Richard's residence at 2233 S. 67th Pl. to attempt contact.

While driving northbound on S. 67th Pl., from W. Beloit Rd., I observed multiple individuals standing in the roadway outside of the residence. Once I parked my vehicle, the individuals began to run inside the residence. I exited my squad and ran up to the residence and made contact with a male party later identified by other officers as Julio R Tompkins, M/W, 06/14/92. Julio stated Richard went inside to use the restroom. Another female who was later identified by another officer as Nicole M Rivera, F/W, 04/17/73, stated she would go inside to get Richard.

**CONTACT WITH RICHARD L TOMPKINS - OFFENDER**

Once Richard exited the south facing door of his residence, officers began speaking with Richard. Richard appeared to be intoxicated. Richard instantly became irate and began screaming, "Shut the fuck up, you are in my yard!" to officers. Due to Richard's high level of intoxication and his demeanor towards law enforcement, officers made contact with Richard and attempted to gain control of him and detain him. Before officers could detain Richard, one of his dogs exited his residence because Nicole opened the side door. The small brown pit bull ran up to Officer Kaye, who stated the pit bull bit him. See Officer Kaye and Officer Stikl's supplemental reports for further detail regarding the bite.

While attempting to detain Richard, Nicole made multiple advances toward officers who were attempting to detain Richard. Nicole was told several times to stay back, but refused to obey officer's orders. Nicole was subsequently arrested for obstructing officers. See Officer Kaye and Officer Stikl's supplemental reports for further details regarding the arrest.

Richard was escorted from the rear of his residence to the front. While attempting to detain Richard in handcuffs, he displayed resistive tension in his left arm. Eventually officers were able to detain Richard in handcuffs for this investigation. Richard was advised he was not under arrest and was only detained for the investigation.

I asked Richard what occurred between he and his son earlier in the night, which he stated, "I am going to kick his ass." Richard explained Mitchell was "hitting on" one of his sister's friends which caused Richard to become upset. Richard stated he, his son, other family and friends were at the Wednesday Night Live event at the State Fair grounds. Richard stated they left the event to go to Happy Tap for some drinks.

Richard stated while at Happy Tap, "All hell broke loose in the bathroom of Happy Tap." He stated there was not any physical fighting, only fighting via social media. Richard stated the argument began when Mitchell sent other male individuals some social media messages, which angered them. Richard did not know who the messages were directed towards. Richard then left Happy Tap and returned

to his residence to confront Mitchell. When Richard arrived at his residence, he stated an argument ensued between them.

Richard stated the argument escalated into a physical altercation. Richard claimed Mitchell punched him first above his right eye. Officers did not observe any injuries to Richard's face. Richard stated he then told Mitchell, "You are out of here, if you ain't out of here by the fucking morning I am killing you." Richard then admitted to punching the left side of Mitchell's jaw with his right hand. Richard showed officers two cuts that were on the knuckles of his right index finger and right middle finger. Richard stated the cuts were from Richard punching Mitchell. Richard said that he would not lie and that he did in fact punch Mitchell.

Richard stated after the physical altercation, he threw Mitchell out of the residence. At that point, everyone gathered outside of the residence to talk about the incident. Richard admitted that everyone ran inside when they observed officers because they knew what was going to happen to them. Richard then stated, "And me, I will pick a fight with you guys, I ain't going to lie, I would pick a fight with you guys. That is why I went inside." Richard denied being involved in any other physical altercations with Mitchell.

I asked Richard why he hit Mitchell and Richard stated it was because of the text messages that Mitchell sent out. Richard stated he was unsure of who Mitchell sent it to, but he saw it because Julio showed him. Richard stated if Mitchell returns to the residence he will punch him again. Richard continued to state that he would, "Beat Mitchell's ass."

**LACK OF CONSENT**

Mitchell did not give Richard consent to assault him or to cause him to fear for his safety.

**ARREST DECISION**

Based on Mitchell's initial 911 call advising he was assaulted by Richard and Richard's admission to punching Mitchell in the mouth, Richard was arrested for DV / DC.

Richard was searched and placed in the back of my squad car for processing at the WAPD. Throughout my entire contact with Richard, he stated in several different ways that he would cause another physical altercation with Mitchell if Richard sees Mitchell again.

**INITIAL RESPONSE**

On 6/14/18, at approx. 0104hrs, Officers responded to the Alibi Bar located at 6540 W. Grant St. for the report of an incident that occurred at 2233 S. 67th Pl.

Other Officers cleared the Alibi Bar to investigate this incident further and I stayed on scene with the victim for this incident.

**STATEMENT BY MITCHELL J. TOMPKINS-VICTIM**

This statement is regarding an incident that occurred on 5/28/18 while at 2233 S. 67th Pl.

Mitchell J. Tompkins, (m/w, 12/31/92), stated his father, Richard L. Tompkins, (m/w, 7/30/70), and he were at their residence which Mitchell moved into approx. one year ago. Mitchell stated an argument occurred that night but could not remember what it was about. Mitchell was in his room and his dad was in the living room. Richard began yelling to Mitchell asking where his phone was and Mitchell told him he had it in his hands. Mitchell was now in the living room and his dad was asking where the Bluetooth speaker was and it was on a table close to where Richard was sitting. Mitchell picked up the Bluetooth speaker and tossed it to his father.

After tossing the speaker to Richard, Richard yelled at him, "You have 30 minutes to get out or I am calling the Police!" Mitchell then told his father to force him to leave. Richard walked over to Mitchell and grabbed him by the neck which made it, "kind of" hard to breathe and stated it felt like he was going to pass out. In order to defend himself Mitchell pushed Richard away by pushing him in his neck. This altercation lasted for approx. ten minutes and the two separated. Mitchell then tried to leave the residence in order for both of them to cool down and Richard told him that if he leaves he is not coming back.

Mitchell was able to leave the residence and approx. 30 minutes later, he received a call from Richard's girlfriend who stated that Richard had calmed down and that he could return to the residence. Mitchell came back to the residence and he and Richard had a few more words and then went to bed.

As I as speaking to Mitchell, he was unsteady on his feet and would sway back and forth at times, his speech was thick and slurred, his eyes were red and glassy and I detected a strong odor of intoxicants emitting from his breath.

**NARRATIVE**

Ofc. Stikl reports:

My Axon Body Worn Camera was operational throughout this incident. The following is a summary of events. For a full transcript, see the video footage.

**CALL FOR SERVICE**

On 06/14/18 at 0104hrs., officers responded to The Alibi Tavern located at 6540 W. Grant St. to speak with an individual identified as **Mitchell J. Tompkins (M/W 12/31/92)**, who claimed to have been assaulted by his father **Richard L. Tompkins (M/W 07/30/70)** earlier in the night. Mitchell advised Richard was wearing a black cloth biker vest and jeans. He believed Richard walked to the Happy Tap Tavern located at 6801 W. Beloit Rd. after the altercation. Officers spoke with the bartender at Happy Tap, who informed officers that the bar had closed and they last observed Richard walking eastbound on W. Beloit Rd. Richard Tompkins currently resides at 2233 S. 67th Pl.

Officers proceeded to his residence in an attempt to make contact with Richard. As Ofc. Brockmann and I turned northbound on S. 67th Pl. from W. Beloit Rd., I observed a group of individuals standing in the street along the west side in front of the address #2233. One of the individuals within the group was an older M/W wearing a black vest and jeans matching the description of Richard. As the group of individuals recognized fully marked West Allis Police Department squads driving towards them, the group of individuals including Richard then sprinted towards the residence and entered #2233.

As officers approached the residence, I observed a M/W, identified as **Julio R. Tompkins (DOB: 06/14/92)**, and a F/W, identified as **Nicole M. Rivera (DOB: 04/17/73)**, standing on the walkway south of the residence. When asked why everyone ran into the residence, Rivera stated they ran after noticing officers in the area. Rivera then proceeded to the south entrance/exit door to the residence holding it open as Richard had exited. Rivera was advised to keep the door closed to ensure their pit bulls would not run loose causing officer safety concerns. In the past an officer had been bit by one of their pit bulls causing injuries.

As officers attempted contact with Richard, I observed a smaller brown pit bull exit the residence and run over toward Ofc. Kaye. At that point, Ofc. Kaye advised the pit bull had bit him. Eventually, the dog was contained inside the residence. As Ofc. Kaye and Ofc. Brockmann escorted Richard from the back yard and along the east side of the residence, I closed the wooden fence door. I attempted to assist officers in detaining Richard in handcuffs, but was unable

to due to Nicole's behavior. She quickly approached me attempting to make contact with Richard by walking between myself and him. I instructed Nicole to back up and had to use my arm as a barrier to keep her from walking any closer causing officer safety issues. Nicole failed to comply with my orders. I had to instruct her multiple times to back up and physically separate her from the area in order for her to comply. Based on Nicole refusing to obey officers orders and attempting to interfere with officers during an investigation causing for concern regarding officer safety issues, her behavior hindered my ability to due my job causing me to focus my attention on her rather then the person of interest in our investigation.

*Let it be noted during my contact with Nicole, I detected a strong odor of intoxicants emitting from her breath, her eyes to be red and glassy and her speech to be slurred.*

\*\*\*This incident was captured on my body camera. It should be noted I did not review the entirety of the camera footage prior to or while writing this report. My report is a synopsis of the incident primarily from memory/notes taken\*\*\*

**PO Kaye Reports:**

On 06/14/15 at approximately 0104hrs, officers responded to the Alibi, 6540 W Grant St, to speak with an individual who claimed to be assaulted by his father. Officers made contact with the victim, Mitchell J. Tompkins (M/W 12/31/92), who explained he was assaulted by his father, Richard L. Tompkins (M/W 07/30/70), a week ago and was threatened by him today. Mitchell indicated he was scared to go home as he believed Richard would assault him again tonight. Mitchell advised Richard was believed to be at the Happy Tap, 6801 W Beloit Rd. See PO Brockmann's Incident Report for further information regarding Mitchell's statement.

**ATTEMPT CONTACT - HAPPY TAP**

Officers responded to the Happy Tap in attempts to locate and speak to Richard. Officers were advised by a Happy Tap employee that Richard was not at the tavern and was believed to have left approximately 20 minutes prior to officer arrival.

**FOLLOW UP - 2233 S 67 PL**

Officers responded to Richard's residence, 2233 S 67 Pl, in attempts to locate and speak to Richard. Upon my arrival, I observed a group of approximately 8 individuals congregated around a vehicle parked in front of the residence. As I approached the group of individuals in my fully marked WAPD SUV, they began to run to the rear entrance of the residence. I stopped and exited my fully marked WAPD SUV, and began to run towards the individual who fled from the street. I ordered the fleeing individuals to stop and identified myself as the Police, to which everyone failed to comply with the exception of Julio R. Tompkins (M/W 06/14/92).

I opened and entered the closed wooden gate of the enclosed yard of the residence, where I made contact with Julio. Shortly thereafter, Nicole M. Rivera (F/W 04/17/73), exited the residence, walked towards the front of the house, and was telling Julio to go inside. Julio began telling Nicole to go inside.

While on scene, I recalled an incident at this same residence where Richard

threatened to shoot Law Enforcement Officers, ran from Police, and resisted officers as well as officer being bitten by a Pit Bull.

At this point, Richard exited the rear door of the residence where I noticed Richard had some sort of holster on his right hip. I asked Richard to come over and speak with me several times to which Richard initially walked towards me, raised his arms out to the side as if he had no idea what I wanted him to do, and suddenly started to move back towards the rear door.

There were multiple individuals in the enclosed yard of the residence, all of who were yelling, arguing with officers, and moving around freely creating an unsafe/chaotic situation. Due to the fact there was no control of the situation, I attempted to utilize heavy control talk and ordered everyone to "Knock it off!" Richard immediately yelled at me to "Shut the fuck up, you are in my yard!"

Based on the fact unsafe/chaotic situation, the fact Richard was a suspect in an assault incident with Mitchell, and Richard's agitated state; I placed Richard hands behind his back and began to walk Richard to the front yard backwards - So I could maintain visual on the other individuals in the yard. PO Brockmann came to assist me. Prior to being able to turn around, Sandra S. Hayes (F/W 03/26/64), attempted to intervene with me escorting Richard from the back yard as she approached me from behind and continually told me to stop.

**Note:** While speaking with both Richard and Nicole, I detected the odor of alcohol emitting from their breath and noticed their red and glassy eyes - Nicole was so intoxicated she urinated herself. Based on my training and experience as a Police Officer, I believed Richard and Nicole to be under the influence of an intoxicant.

**DOG BITE**

While I walked Richard out of the enclosed yard a small brown/black Pit bull exited the rear door of the residence, ran around everyone towards Richard and I, and attempted to bite me from behind. The Pit bull was unsuccessful at completing a full bit, but was able to nip/pinch my upper left hamstring area with its teeth. This caused me pain and left a red mark on my leg. The dog bite did not break skin and I did not need any medical attention. I did take photographs of the injury.

**RESISTIVE EPISODE**

After the Pit bull bit me, I continued to walk Richard to the front of the residence where I stabilized Richard up against the front of the house so he could be detained. PO Brockmann started to place Richard into handcuffs where Richard display resistive tension in his arm - Low level a agitation - to which I forcibly secured Richard against the residence. While PO Brockmann completed handcuffing Richard, Nicole attempted to intervene with officers. PO Stikl had to physically move Nicole backwards and order he to back up. After Richard was

Nicole was booked at the WAPD Substation and transported back to the residence. Nicole was given a local court date of 07/30/18 at 0830hrs.

**CANINE QUARANTINE**

At the time of this investigation I was wearing my WAPD issued body camera, which was functional and activated. See video recording for precise details as the following is a summary based off little or no review.

**INITIAL RESPONSE**

On 06/14/2018 at approx. 0129 hrs, officers were continuing this investigation at 2233 S 67 Pl, when they advised they were out with a large group of uncooperative people. I responded to the location to assist. By the time I arrived, numerous people were detained in custody and being questioned. I was asked to speak with a female in her vehicle who was not being detained.

**STATEMENT OF SANDRA S. HAYES**

I made contact at the driver's door with Sandra S. Hayes w/f 03/26/1964, who advised she was dating one of the men being detained on the front porch, Richard L. Tompkins w/m 07/30/1970. Sandra stated she knew that Richard went out drinking this evening with a large group of people, including his son, Mitchell J. Tompkins w/m 12/31/1992. Sandra advised Mitchell and Richard often don't get along with each other, especially when they had been drinking.

Sandra stated she was at work at Sunrise Health Services when she got a call from Richard's other son, Julio Tompkins, telling her that Mitchell and Richard were not getting along with each other and suggesting she come home. Sandra didn't do much else until she received a call from Richard, telling her that if things continued between him and Mitchell, he was going to end up getting arrested tonight. Sandra left work at that time and returned to the house.

**ARRIVAL**

**STATEMENT - DONALD T. GALVAN**

Donald stated he was drinking at Happy Tap, 6801 W. Beloit Rd, for the past two hours. He arrived at 2233 S. 67 Pl. approximately 15 minutes prior to officer arrival. Donald initially stated he did not observe an argument or a physical confrontation at the tavern. After speaking with him for several minutes, Donald advised that there was an argument.

Donald stated his friend Mitch likes Cody, but Cody does not like Mitch. Mitch would not leave Cody alone, so Richard intervened and told Mitch to relax. This is all the information that Donald could provide.

**NARRATIVE**

Officer Fletcher reports...

**INITIAL RESPONSE**

On 06/14/18 at approx. 0129hrs., I responded to 2233 S. 67 Pl. as Acting Sergeant to assist officers in a domestic abuse investigation. Officers on scene requested additional officers, and advised they were out with several uncooperative subjects. Officer Kaye also radioed that he was bit by a dog.

Upon arrival, I observed several subjects screaming at officers outside of the residence as officers were attempting to detain them. I assisted in placing the remaining subjects in handcuffs based on their uncooperative and argumentative behavior. I then spoke with Officer Kaye, who was reportedly bit by a dog during the incident.

**CONTACT WITH OFFICER KAYE**

Officer Kaye advised me he was bit by a small brown pit bull mix that ran out the side door of the residence as they were attempting to detain subjects outside of the residence. Officer Kaye advised he was bit one time in the upper left hamstring area. I was unable to view Officer Kaye's injury on scene based on the injury location. It was believed that the dog that bit Officer Kaye was the same dog that bit Officer Carlson in a similar incident the previous year.

**CONTACT WITH DOG OWNER**

I spoke with the dog's owner, Sandra S. Hayes F/W 03/26/64 who was on scene. Sandra advised me that the dog's name was Spike, and that he is an approx. 3 year old brindle pit bull mix. Sandra confirmed Spike was the dog that bit Officer Carlson last year. Sandra claimed Spike was quarantined after the last incident and forced to receive the rabies vaccination. Sandra as unable to provide any documentation for the rabies vaccination.

**DOG BITE PAPERWORK**

Based on Sandra's inability to produce rabies vaccination paperwork, I completed the Dangerous Dog Order and the West Allis Health Department Rabies Quarantine Order. Copies of the forms were uploaded to the case file, and the originals were turned into the Commanding Officer. I additionally notified
