That the Executive Director of Economic Development, or his designee, along with the approval of the is hereby authorized to make such non-substantive changes, modifications, additions and deletions to and from the various provisions of the Professional Services Contract, including any and all attachments, exhibits, addendums and amendments, as may be necessary and proper to correct inconsistencies, eliminate ambiguity and otherwise clarify and supplement said provisions to preserve and maintain the general intent thereof, and to prepare and deliver such other and further documents as may be reasonably necessary to complete the transactions contemplated therein.

NOW THEREFORE BE IT RESOLVED by the Common Council hereby approves and allocates \$16,000 for Bublr Bikes operations in 2024 Calendar Year.
