An Ordinance to Establish Parking Restrictions on the North Side of the 8400 to 9100 Blocks of W. Greenfield Avenue.

WHEREAS, on March 11, 2014 the Wisconsin Department of Transportation requested the temporary restriction of parking along the north side of Greenfield Avenue from S. 84th Street to S. 92nd Street. The proposed restriction would occur from 3:00 pm to 6:00 pm on Mondays through Fridays from October 1, 2014 until October 31, 2017, and

WHEREAS, this request is in conjunction with proposed improvements along Greenfield Avenue as part of the Zoo Interchange Project's local street traffic management plan. To maintain safe and efficient traffic flow along Greenfield Avenue, the Zoo team proposes improving the traffic signals at 84th Street and 92nd Street, upgrading the school crossing at 87th Street, and adding pavement marking to create an additional temporary westbound through lane from 84th Street to 92nd Street, and

WHEREAS, once the Zoo Interchange and freeway construction is complete, the Wisconsin Department of Transportation will mill and overlay the entire pavement on Greenfield Avenue from 84th Street to 92nd Street, including parking lanes, new pavement markings and a proposed bike lane, and

WHEREAS, all of this work will be funded as part of the Zoo Interchange Project at no cost to the City of West Allis.

NOW, THEREFORE, the Common Council of the City of West Allis do ordain as follows:

PART I. Pursuant to Section 10.10 of the Revised Municipal Code, the following parking restriction is established:

Street: W. Greenfield Avenue

Block: 8400 to 9100

Side: North

Restriction: No Parking 3:00 PM to 6:00 PM, Monday through Friday

PART II. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

PART III. This ordinance shall take effect and be in force from and after its passage and publication and after the Wisconsin Department of Transportation installs the necessary signage to support this ordinance.
