

An Ordinance to Repeal and Recreate Subsection 6.03(2) of the West Allis Revised Municipal Code Relating to Public Welfare and Peace.

The Common Council of the City of West Allis do ordain as follows:

PART I. Subsection 6.03(2) of the Revised Municipal Code of the City of West Allis is hereby repealed and recreated to read:

6.03 PUBLIC WELFARE AND PEACE.

* * *

(2) Posting Signs, Advertisements or Displays. No person shall put up, erect, fasten, post, paint or maintain any sign, picture, poster, advertisement, symbol, structure, display or any other item of any description upon any curb, sidewalk, fence, board, barrel, box, case, railing, pole, post, barricade, material, bridge, structure or building of any kind placed upon any street, alley, public way or public ground.

* * *

PART II. All ordinances or parts of ordinances, contravening the provisions of this ordinance are hereby repealed.

PART III. This ordinance shall take effect and be in force from and after its passage and publication.
