**RESOLUTION AUTHORIZING THE DIRECTOR OF PUBLIC WORKS TO
AMEND AN EXISTING AGREEMENT WITH RUEKERT & MIELKE, INC. FOR
ENGINEERING CONSULTING SERVICES RELATED TO THE ORCHARD HILLS
CANAL CONCRETE CHANNEL REMOVAL AND RESTORATION PROJECT IN
AN AMOUNT NOT TO EXCEED \$154,984**

WHEREAS, the City has an existing agreement with Ruekert & Mielke, Inc. for engineering consulting services related to the initial survey and concept design of the Orchard Hills canal project; and,

WHEREAS, the City will need further assistance from Ruekert & Mielke, Inc. to perform the design, bidding, and construction services for the Orchard Hills canal project.

NOW THEREFORE, be it resolved by the Mayor and Common Council of the City of West Allis that up to \$154,984 is approved for Ruekert & Mielke, Inc. for the design, construction, and grant administration services for the Orchard Hills canal project; and,

BE IT FURTHER RESOLVED that the Director of Public Works is authorized to enter into an amended agreement for Engineering Consulting Services with Ruekert & Mielke, Inc.; and,

BE IT FURTHER RESOLVED that funding for this work has been budgeted and will be charged to account 540-1807-538.75-01.
