The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of December.

# **Incident reports:**

# Case # 13-011008, 12/08/2013, at 0050 hrs - 7527 W. Becher St. Flappers

On 12/08/2013, at approximately 0050 hrs., Officers responded to7527 W. Becher St., Flappers, for a physical altercation. The tavern was hosting a charity fundraiser when, patron Michael David Kaminski, who had been in the bar for less than two hours, began arguing with a customer. He was asked to leave by the owner and bouncer and he exited the premise. Kaminski then loitered outside the premise. The bar owner told Kaminski he needed to move along. Kaminski refused to leave. The owner stated he was calling the police. Kaminski waited for John Jens to exit the tavern. Kaminski then came up behind Jens and punched and/or pushed Jens to the ground. Jens complained of a scraped knee, injured ribs and chest pain. WAFD responded and conveyed Jens to Froedtert Hospital. Kaminski was arrested and booked for Battery. This case was reviewed by the Milwaukee Cty District Attorney's Office. Kaminski was charged with Misdemeanor Battery.

### Case # 13-011083, 12/10/2013, at 2328 hrs – 1753 S. 68 St. Dopps Bar

On 12/10/2013, at approximately 2328 hrs., Officers responded to 1753 S. 68 St., Dopps Bar for a bar fight. Kyle Robinson and his cousin, Ronald Frankes, were the cause of the physical altercation. The bar owner, Tammy Dopp, broke the fight up. Frankes left prior to Officers arrival. Robinson was arrested and issued a Municipal Citation for Disorderly Conduct. Frankes was booked out of custody and mailed a Municipal Citation for Disorderly Conduct.

# Case # 13-011174, 12/13/2013, at 2314 hrs - 9105 W. Lincoln Av. The Draft

On 12/13/2013, at 2314 hrs. Officers responded to the parking lot of The Draft, 9105 W. Lincoln Av. for a report of a male individual who had broken a car window. Officers made contact with Jaymie Henrickson, who stated she had been drinking at The Draft. She and her boyfriend, Steven Raatz, got into a verbal argument in the parking lot. Steven grabbed onto Jaymie's car window, causing it to shatter. Steven was arrested for Domestic Violence/Criminal Damage to Property. This case was reviewed by the Milwaukee Cty District Attorney's Office.

## Case # 13-11614, 12/28/2013, at 0253 hrs - 9141 W. National Av. The Oval Bar

On 12/28/2013, at approximately 0253 hrs., Officers were dispatched 9141 W. National Av, The Oval Bar, regarding a patron placing a loaded firearm on top of the bar. The bartender placed the weapon behind the bar and continued to serve the patron. At bar closing, the bartender refused to return the firearm to the Offender because he was intoxicated. The Offender, Robert J. Jadin, left prior to Officers arrival. The bartender advised the Officer she did not call the police department immediately after confiscating the firearm, because she had a full bar of patrons and she was trying to keep things low key. Jadin was later arrested for the incident. This case was reviewed by the Milwaukee Cty District Attorney's Office. Jadin was charged with three Misdemeanor Charges; Disorderly Conduct – while armed, Carrying a Concealed Weapon, and Going Armed in a Class B Establishment.

Note: I recommend ordering the bar owner & bartender in for questioning, as this incident is highly concerning in regard to public safety and officer safety.

### **Tobacco and Alcohol Compliance checks:**

- On 12/10/2013, a tobacco compliance check at 17 randomly selected West Allis businesses that have a license to sell tobacco was conducted. The check was completed through the use of a 17 year old female who attempted to purchase a pack of Newport cigarettes. All of the 17 businesses requested identification from the 17 year old female and did not complete the sale.
- No alcohol compliance checks were conducted during this reporting period.

## **Violation of Wisconsin Clean Air Act Smoking Ban:**
