RE: Leasing of Parking Lot

84th Street and Cleveland Avenue

Dear Board of Public Works Members:

We have received two requests to lease the City owned parking lot at the corner of 84th Street & Cleveland Avenue (Please see attached drawing). The requests are from Mr. Dennis Ermi, representing Michael's Restaurant and from James & Kim Ellis, new owners of the corner building at 2711 84th Street. Apparently, there have been words between Mr. Ermi and the new owners about the use of the parking lot. The parking lot is not leased and as far as the City is concerned, open parking for anyone at this time (There are also no posted time restrictions).

Of course, we have conflicting interests here. Both businesses are short of parking and need every space they can get. As soon as Mr. Ermi learned that the Ellis' were requesting a lease, he submitted his request.

I have alerted both Alderman of the problem. I would suggest that before we look at a lease(s), a meeting be arranged to see if a compromise can be negotiated.

We are not looking at any formal action on Tuesday night, but we would like your input on how to proceed.
