## **AGREEMENT**

This **AGREEMENT** is made and effective as of the date signed below; by and amongst the City of West Allis, hereinafter referred to as "City," and Diane D. Plumeri, hereinafter referred to as "Plumeri."

**WHEREAS**, on January 1, 2014, the City assessed and levied a 2014 personal property tax pursuant to Chapter 74 of the Wisconsin Statutes against Plumeri in the amount of Four Hundred Seven and 43/100 Dollars (\$407.43);

WHEREAS, interest of 1.5% per month accrues on the unpaid principal amount of the personal property tax;

WHEREAS, Plumeri is delinquent in paying said 2014 personal property taxes along with interest and penalty for a total amount of Four Hundred Thirty Seven and 99/100 Dollars (\$437.99), as of June 15, 2015; and,

**WHEREAS**, the City Clerk's and the Health Department may withhold the issuance of a 2015-2016 Food permit, Class B tavern license, and Dance hall license to Plumeri until she has paid said delinquent personal property taxes in full; and

**WHEREAS**, Plumeri seeks to obtain a 2015-2016 Food permit, Class B tavern license, and Dance hall license for Plumeri as soon as possible so as to not interrupt her business operations for the current year;

NOW, THEREFORE, based upon the foregoing, the City and Plumeri agree to the following:

Plumeri agrees to pay the 2014 delinquent personal property taxes, hereinafter referred to as "taxes," on the following terms:

- Plumeri will pay One Hundred Forty Six Dollars to the City of West Allis on or before June 30, 2015 for the delinquent taxes. The check should be made <u>payable to</u> <u>the City of West Allis</u> and directed to Assistant City Attorney Jenna R. Merten at City Hall.
- 2. Plumeri will pay One Hundred Forty Six Dollars per month to the City of West Allis on or before the 30<sup>th</sup> of each month (July 2015 and onward) until the balance of taxes principal and interest is paid in full.

In the event that Plumeri fails to adhere to the terms of this **AGREEMENT**, the City reserves its right to immediately revoke any and all licenses and permits granted to Plumeri without further notice, at which point Plumeri would no longer be able to legally operate her business within the City of West Allis. In the event that the City takes action to revoke any licenses, Plumeri maintains her right to appeal said revocation to the License and Health Committee of the City of



West Allis. The City also reserves its right to pursue legal and/or tax intercept proceedings to collect the delinquent tax.


