Reference: Danny's Tavern...1900 S. 60th Street

License and Health Committee Members,

The letter is being presented for your consideration regarding the status of the Class B Intoxicating Liquor (Tavern) license for the establishment known as "Danny's" located at 1900 S. 60th Street. As you are well aware, a letter of this nature from the Office of Chief of Police does not occur all that often, as the vast majority of the taverns in the City of West Allis have an effective strategy and a clear understanding of what is required to operate a "neighborhood friendly" establishment. In retrospect, the taverns at this location...Danny's (2011 - Current), Mario's (2005 – 2011)...Kick's (2000 – 2004) have brought crime (violent & property) to this neighborhood that has negatively impacted the quality of life for our citizens and businesses/patrons from the surrounding area.

I have attached a brief summary from Crime Analyst Chrisie Hunter giving you some historical insight into this location. As you can see from this summary, the Police Department has expended significant law enforcement resources on this location since 2000 with the most substantial increases starting in 2006. Identifying the need for a larger police presence, our officers have conducted approximately "300" tavern checks in the past six years. The effectiveness of these checks has been minimalized by the management/ownership failing to promote responsible bar/tavern operations.

The following are my recommendations that I offer for consideration:

- 1. Revocation of all Class B licenses issued to current license holder.
- 2. No additional Class B licenses are to be issued to the building located at 1900 S. 60th.

If revocation is not a viable option, I offer the following for consideration:

- 1. Extended suspension of Class B License
- 2. Permanent nightly closing at 10:00 p.m.
- 3. Installation of cameras inside establishment with full access given to West Allis Police Department
- 4. Installation of external cameras by West Allis Police with full cost being provided by building owner
- 5. Selection of "music genres" that fulfill entertainment needs, but does not promote or contribute to aggressive/violent behavior of patrons
- 6. Elimination of "live" or "open-mic" music events
- 7. Costs for police services will be reimbursed by building owner
- 8. Elimination of drink specials
- 9. Increase available food choices
- 10. Training of all bar staff to include, but not limited to: Monitoring drinking to prevent drunkenness, promoting slower drinking rates, prohibiting underage drinking, providing reduced-alcohol or nonalcoholic beverages, requiring or encouraging food service with alcohol service, handling of patrons non-violently, eliminate crowding, establishing and enforcing clear rules of conduct for bar patrons, etc.

Until you reach a determination on the status of this license, I have ordered additional law enforcement personnel on overtime to be assigned specifically to this location. We have also deployed additional technology in the area to monitor this tavern from our Communications Center.

In conclusion, I appreciate the opportunity to address my concerns and offer my recommendations. It is my hope that your decision on this matter will have a positive impact on the neighborhood, its citizens and businesses and the safety of our police officers.


Michael Jungbluth Chief of Police Tavern Report: 1900 S. 60 St. 8/22/12 CA Hunter West Allis Police Department

Calls for Service (2006-present)

West Allis Police Department has responded to the tavern located at 1900 S. 60 St. 627 times (not including follow up conducted by officers and calls for service, which were cancelled). Of the 627 calls for service, officers conducted tavern checks 299 times. Criminal activity most often present at this location consisted of the following: suspicious activity (SA), trouble calls (TC), vehicle complaints (VC), disorderly conduct (DC), request for assistance (RFAS), liquor laws (LL), theft (T), assault (AS), noise complaint (NC), weapons (WEAP), and drugs (CSUB). Table 1 displays all calls for service, while the chart displays the more serious offenses.

Officers wrote 62 incident reports, 22 citations, 3 OWI reports, 8 warnings, and 3 updates (Table 2).

Between 2005 and present, Mario Morgese has been the owner/co-owner of the bar at 1900 S. 60 St. He currently owns the bar, but Daniel R. Seiy is the license holder/agent who runs the establishment.

Historical Data: (pre 2006)

Officers responded to 1900 S. 60 St. 120 times from 1989-2005 and wrote 60 reports. Significant calls for service include a homicide in 1999, a sexual assault in 2001, 11 assaults occurred during six of the years, while four weapons complaints were taken during three years (Table 3). There was a significant increase in calls for service beginning in 2000, when the establishment became Kick's Tavern (2000-2004), under the ownership of Wayne Paluch (Chart 2). In 2005, it became known as Mario's (2005-2011).




Chart 2: Calls for Service: 1989-2012.
