Ordinance to amend Section 12.40(1)(nn) and 12.40(2)(t) of the Revised Municipal Code to permit theaters in the Downtown Central Business District of West Allis as a permitted or special use based upon the floor area.

The Common Council of the City of West Allis do ordain as follows:

PART I. Section 12.40(1)(nn) of the Revised Municipal Code of the City of West Allis is hereby amended, as follows:

12.40 Central Business District

(1) Permitted Uses

(nn) Theaters, limited to a maximum of up to 5,000 Square Feet of building area devoted to theater use and subject to the provisions of Sec. 9.28 of the Revised Municipal Code.

PART II. Section 12.40(2)(t) of the Revised Municipal Code of the City of West Allis is hereby amended, as follows:

**

(2) Special Uses

(t) Theaters, greater than 5,000 Square Feet of building area devoted to theater use and subject to the provisions of Sec. 9.28 of the Revised Municipal Code.

PART III. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

PART IV. This ordinance shall take effect and be enforced from and after its passage and

NOTICE OF NEWLY ENACTED ORDINANCE Please take notice that the City of West Allis enacted Ordinance No. O-2011-0083, Ordinance to amend Section 12.40(1)(nn) and 12.40(2)(t) of the Revised Music-ipal Code to permit theaters in the Downtown Central Business District of West Allis as a permitted or special use based upon the floor area, on January 8, 2012. The ordinance permits the-aters as a permitted use up to 5,000 square feet in floor area, or, as a special use when over 5,000 square feet in floor area. In either case such uses are sub-ject to the provisions of Sec. 9.28 of the Revised Municipal Code which regulates adult orientated uses.
