

Resolution Constituting an Order to Remove an Encroachment in the City Right-of-Way at 5923 West Lincoln Avenue.

WHEREAS, the Common Council by Resolution No. 27047 adopted March 19, 2002, approved a Privilege for Encroachment (Major) beyond the lot line and within the public right-of-way to NG Services, Inc. ("Owner") at 5923 West Lincoln Avenue for, among other things, landscaping and partial parking stalls on that part of the right-of-ways of South 60 Street and West Lincoln Avenue (the "Encroachments"); and,

WHEREAS, the Owner, since the approval date, has not fulfilled the requirements of the Privilege for Encroachments by not supplying the City of West Allis with the required Performance Bond or Cash Bond.

NOW, THEREFORE, BE IT RESOLVED that the Owner of the property at 5923 West Lincoln Avenue, in the City of West Allis, Milwaukee County, Wisconsin be and is hereby ordered to remove the Encroachments from the public right-of-way within ten (10) days of this resolution.

BE IT FURTHER RESOLVED that if the Encroachments are not removed as herein provided, the City of West Allis will remove the Encroachments at the Owner's expense; all as made and provided in the Privilege for Encroachment.

BE IT FURTHER RESOLVED that the City Administrative Officer, Clerk/Treasurer be and is hereby directed to serve a certified copy of this resolution upon the Owner of the aforesaid property at 5923 West Lincoln Avenue by Certified Mail, Return Receipt Requested.

This Order is authorized and made pursuant to Section 86.04 of the Wisconsin Statutes.
