
Michael J. Czaplewski, being duly sworn, on oath deposes and states as a complaint against Deanatony, Inc. as follows:

1. That the complainant is a resident of the City of West Allis, is the duly elected Alderperson for the First Aldermanic District in the City of West Allis, is the chair of the License and Health Committee, and makes this complaint at the direction of the License and Health Committee of the West Allis Common Council.
2. That the information contained in this complaint comes from the complainant's review of official records maintained by the City of West Allis, which records complainant believes to be reliable and accurate.
3. That Deanatony, Inc. is the holder of a Food-Related Permit to sell/serve food under Chapter 97 and 254, Wis. Stat., issued by the West Allis Common Council and is located at 2935 South 108<sup>th</sup> Street, West Allis, Wisconsin.
4. That Deanatony, Inc. does business as "Cold Stone Creamery."
5. That Anthony Bennett Volpe is the registered agent of Deanatony, Inc.
6. That the City of West Allis assessed and levied a 2013 personal property tax pursuant to Chapter 74 of the Wisconsin Statutes against Deanatony, Inc. in the amount of One Thousand Eighty-Four and 72/100 Dollars (\$1,084.72).


7. That Deanatony, Inc. has not paid the personal property taxes in full.
8. That pursuant to Section 1.08(9)(a) of the West Allis Revised Municipal Code, no City license or permit shall be issued unless the applicant shall first have settled any delinquent tax obligation owed to the City.
9. That the conduct of Deanatony, Inc. is contrary to West Allis Revised Municipal Code Section 1.08(9)(a) and is grounds for non-renewal, suspension, or revocation of its Food-Related Permit/License.

WHEREFORE, Michael J. Czaplewski, requests that Deanatony, Inc., c/o registered agent Anthony Bennett Volpe, be summoned to appear before the License and Health Committee of the West Allis Common Council to answer this complaint and, if the material allegations of the complaint are denied, that a hearing be held to determine whether the Food-Related Permit/License of Deanatony, Inc. should be revoked, suspended, or not renewed.
