

Resolution Relative to the Notice of Hearing for the Vacation and Discontinuance of a Part of the Public Right-of-Way North of West Greenfield Avenue Between South 63rd Street and South 64th Street.

WHEREAS, the City is considering vacating and discontinuing a part of the Public Right-of-Way North of West Greenfield Avenue between South 63rd Street and South 64th Street.

NOW, THEREFORE, BE IT RESOLVED that the Notice of Hearing, a copy of which is attached hereto, for the vacation and discontinuance of a part of the Public Right-of-Way North of West Greenfield Avenue between South 63rd Street and South 64th Street, be published in the official City newspaper on December 22nd, 2006, December 29th, 2006 and January 5th, 2007; that the Hearing be scheduled before the Common Council on January 16th, 2007, at 7:30 p.m., or as soon thereafter as the matter may be heard; that a copy of the aforesaid Notice be served or mailed more than thirty (30) days prior to the Hearing in the manner prescribed by the law on the owners of all of the frontage of the lots and lands abutting upon the said portion of public right-of-way proposed to be discontinued.

NOTICE OF HEARING

The Common Council of the City of West Allis will hold a Public Hearing on January 16th, 2007, at 7:00 p.m., or as soon thereafter as the matter may be heard, in the Common Council Chambers of the City Hall, 7525 West Greenfield Avenue, West Allis, Wisconsin, upon the Resolution herein described and will act upon said Resolution at said time and place. Said Resolution was introduced into the Common Council of the City of West Allis on December 5th, 2006, and proposes the discontinuance and vacation of a part of the Public Right-of-Way North of West Greenfield Avenue Between South 63rd Street and South 64th Street, legally described as follows:

Part of the public right-of-way adjacent to the Lots 22 thru 26 in Block 5 in the Resubdivision of Soldiers Home Heights Company's Subdivision in the Southeast ¼ of Section 34, Township 7 North, Range 21 East, in the City of West Allis, County of Milwaukee, State of Wisconsin, more particularly described as follows:

Beginning at the southwest corner of said Lot 22; thence Westerly, 2.00 feet; thence Northerly, 237.00 feet, parallel with east right-of-way line of South 64th Street; thence Easterly, 2.00 feet, to the northwest corner of said Lot 26; thence Southerly 237.00 feet, along said east right-of-way line, to the Point of Beginning.

Also, part of the public right-of-way adjacent to the Lots 13, 14 and 15 in Block 5 in the Resubdivision of Soldiers Home Heights Company's Subdivision in the Southeast ¼ of Section 34, Township 7 North, Range 21 East, in the City of West Allis, County of Milwaukee, State of Wisconsin, more particularly described as follows:

Beginning at the southeast corner of said Lot 15; thence Northerly, 177.00 feet; along west right-of-way line of South 63rd Street, to the northeast corner of said Lot 13; thence Easterly, 3.00 feet; thence Southerly, 177.00 feet parallel with said west right-of-way line; thence Westerly, 3.00 feet, to the Point of Beginning.
