

**CITY OF WEST ALLIS
RESOLUTION R-2025-2967**

**RESOLUTION TO AUTHORIZE THE PURCHASE OF NEW ROLL-OFF
CONTAINERS FROM POYNETTE IRONWORKS FOR A TOTAL SUM OF \$29,376**

WHEREAS, the Department of Public Works is in need of replacing two 16-yard, 21-year-old and two 20-yard, 27-year-old roll-off containers which have exceeded their service life; and,

WHEREAS, the Department of Public Works has received and reviewed multiple proposals for replacement roll-off containers; and,

WHEREAS, item 60 of the 2025 approved capital improvements budget includes \$30,000 for the purchase of new roll-off containers; and,

WHEREAS, the Fleet Services Division of the Department of Public Works has determined that the proposal of Poynette Ironworks meets all desired specifications, and that the proposal received is reasonable; and,

WHEREAS, the Common Council deems it to be in the best interest of the City of West Allis that the proposal of Poynette Ironworks be accepted;

NOW THEREFORE, Be It Resolved, by the Mayor and Common Council of the City of West Allis that the proposal dated August 26, 2025 by Poynette Ironworks for furnishing and delivering two 16-yard and two 20-yard roll-off containers for a total sum of \$29,376 is accepted; and,

Be It Further Resolved that the purchase shall be charged to Account Number 550-4233-535.70-03; and

Be It Further Resolved that the Finance Department is authorized to enter into a contract for the aforesaid equipment.
