Officer Behnke reports... Suspicious Activity

Officers spoke with Carlos Rodriguez Rivera (M/W [REDACTED]) who was playing with a bright orange dart gun in the business with two other juveniles. I spoke with Sandy Juarez Antonio (F/W [REDACTED]), an employee, who allowed me to review surveillance footage of the incident and confirmed it was only children with toy guns playing. The business was closed for a private family event and there were no violations observed.
