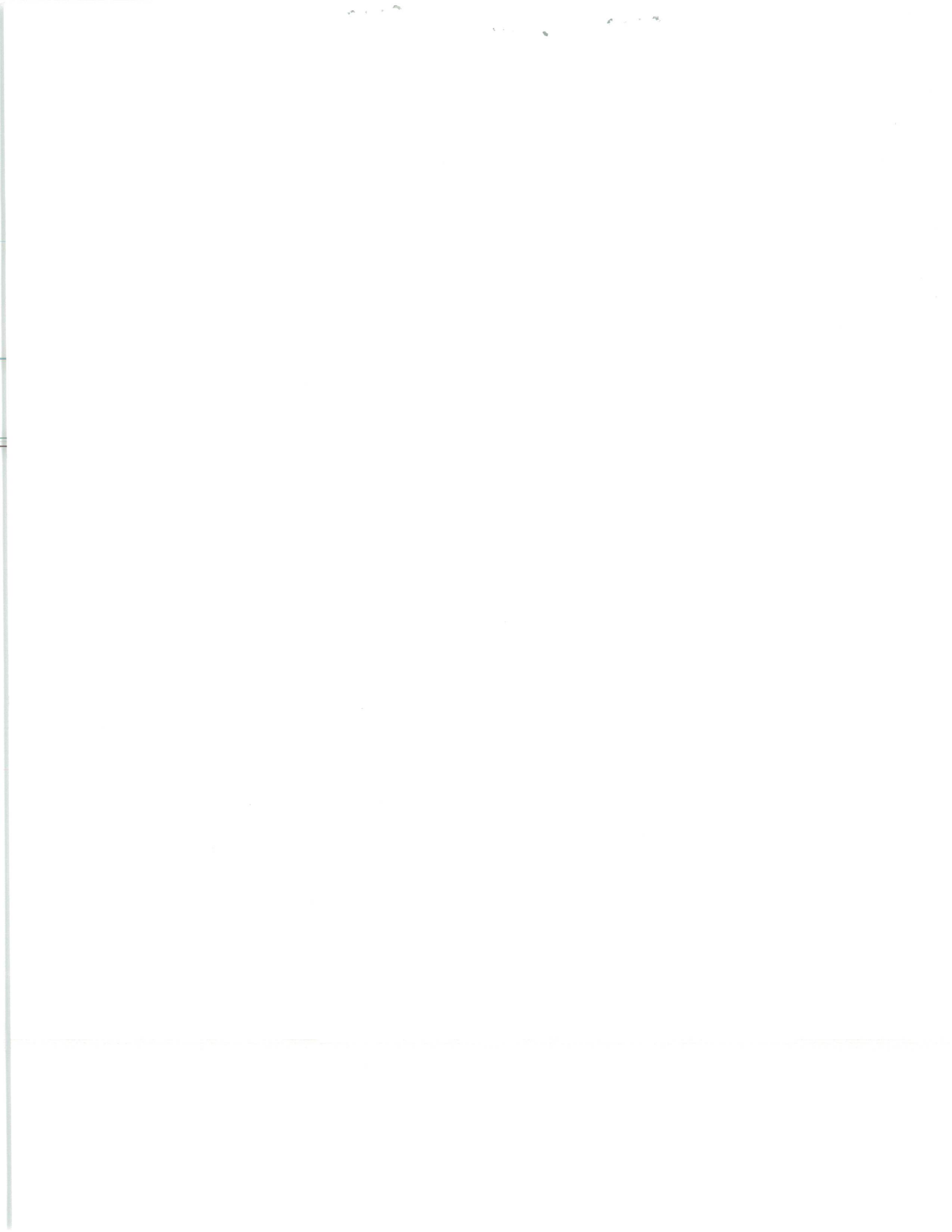
PART II. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

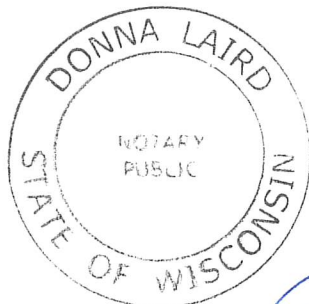


