PART I. Section 16.62 of the Revised Municipal Code is hereby recreated as follows:

(16) Special Inspection With Written Report

(17) Permit Refund. Excepting plan review fee or special fees, that portion in excess of \$100.00 is eligible to be refunded to the permit holder for work not started. A refund request shall be made in writing to cancel the permit and received in the Department of Building Inspections within 120 days of issuance of the permit. Requests thereafter are administered in accordance with Common Council Policy & Procedures for permit refunds.

(18) The Director of the Department may waive or reduce the fee of any permit upon proper cause. Permit fees for City work by City plumber is waived.

PART II. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

PART III. This ordinance shall take effect after publication and become effective on June 1, 2010.
